**MEETING NOTIFICATION** - The County Council Members, Department Heads, requesting general public and the Press were informed of the meeting in a timely manner.

**CALL TO ORDER** – Chairman Wood called the meeting to order and invited all to stand for the invocation and the Pledge of Allegiance. Councilwoman Anderson provided the invocation.

**APPROVAL OF AGENDA** – Chairman Wood called for approval of the agenda with any additions.

Administrator Segars advised Council that the executive session legal briefing is no longer necessary and that a budget update will be provided.

COUNCILMAN NASH made the MOTION to approve the agenda as presented with the addition and deletion; VICE CHAIRMAN TOLLISON SECONDING; VOTE 6-0.

**APPROVAL OF MINUTES** – VICE CHAIRMAN TOLLISON made the MOTION to approve the minutes from the May 26, 2015 regular session of Council. COUNCILMAN JONES SECONDING; VOTE 6-0.

**VARIANCE SETBACK REQUEST – MARBRY RIDING ARENA – GRAY COURT COMMUNITY** – Addressing the variance setback request consideration for the Marbry Riding Area in the Gray Court Community, Chairman Wood said, “I discussed this with the Staff, a member of the Planning Commission. The Planning Commission has reviewed this request for a variance with County Staff and with the property owners and at their meeting on May 19<sup>th</sup> voted unanimously to approve the variance request. I think that the actions taken by the Planning Commission is appropriate as a final statement and I do not believe that any further action needs to be taken.



**RESOLUTION #2015-16 – “A RESOLUTION PROVIDING FOR A FEE IN LIEU OF TAX ARRANGEMENT BETWEEN LAURENS COUNTY AND CB&I LAURENS, INCORPORATED –**

Attorney Cruickshanks stated, “This Resolution and the following Ordinance refers to CB&I investing over four million dollars (\$4,000,000) and adding about fifty six (56) new jobs. In the Ordinance, it references a special source revenue credit. The company did a Fee Agreement in November, 2008 and for some reason did not take advantage of the financial benefits that was provided by the agreement. They realized over the last year when expansions have taken place and are now wanting to amend their returns which resulted in a refund of between fifty five and sixty thousand dollars (\$55,000 - \$60,000) to the company. In negotiations it was felt that they were entitled to these funds so we offered an offset of their credit an additional twenty five percent (25%) for four (4) years. We would have owed them back these funds and after four (4) years, it drops back to thirty percent (30%)”.

COUNCILMAN PITTS made the MOTION to approve the Resolution for a Fee In Lieu of Tax Agreement Between Laurens County and CB&I Laurens, Incorporated with COUNCILMAN JONES SECONDING”; VOTE VOTED 5-0-1 (Vice Chairman Tollison abstained).

**FIRST READING ORDINANCE #791, “AN ORDINANCE AUTHORIZING THE EXECUTION AND DELIVERY OF A FEE AGREEMENT BY AND BETWEEN LAURENS COUNTY, SOUTH CAROLINA AND CB&I LAURENS, INC. PROVIDING FOR A PAYMENT OF A FEE IN LIEU OF TAXES, THE ISSUANCE OF SPECIAL SOURCE REVENUE CREDITS, AND OTHER MATTERS RELATED THERETO; AND AUTHORIZING AN EXTENSION OF THE TERMINATION DATE OF A FEE AGREEMENT ENTERED INTO BY AND BETWEEN LAURENS COUNTY AND CB&I LAURENS, INC. (AS SUCCESSOR TO B.F. SHAW, INC.) DATED NOVEMBER 25, 2008”.** – COUNCILMAN PITTS made the MOTION to approve the Ordinance for a Fee In Lieu of Tax Agreement between Laurens County and CB&I Laurens, Incorporated with COUNCILMAN JONES SECONDING for discussion.

Councilwoman Anderson asked why the County had to grant a feature that the Company did not use or understand. Attorney Cruickshanks replied, “The Agreement is still in place. When the Company bought BF Shaw, they bought the Agreement too. With the Agreement still being in place and not honoring the 2008 Agreement, the County would be in violation”.

Councilman Pitts asked how the Fee-In-Lieu-Of- Tax be split? Attorney Cruickshanks replied that this is a standard provision where the County and School apportionment would be sixty five / thirty five (65/35) – sixty five (65) to School District 55 and thirty five (35) to Laurens County.

COUNCIL VOTED 5-0-1 (Vice Chairman Tollison abstained).

**FISCAL YEAR 2015-2016 - BUDGET SUMMARY – FOURTH DRAFT** – Finance Director Kirk reported the following updates to the proposed working budget:

- c.) Capital Equipment two hundred sixty nine thousand one hundred forty five dollars (\$269,145).

Councilman Pitts asked if the premium includes the new building. Mr. Wilson, Vehicle Maintenance / Procurement Officer replied that it did not because the actual premium will be due and payable during the next budget session.

**ADMINISTRATIVE REPORT** – Administrator Segars reminded Council of the Legislative Breakfast to be held on Friday morning and briefed Council on a revenue option.

Administrator Segars said, “As part of the budget process, and as a suggestion to help us with the budget process, I would like to offer this as a possible revenue source to assist us with our budget deliberations for the fiscal year. The Laurens County Fire Service is strong on their reserve balances and Council should consider the transferring of thirty thousand dollars (\$30,000) to the County in lieu of the Administrative help that they do receive from Administration, Finance, Human Resources and a variety of other departments. Mr. Lindley had said that he has no problem with this transfer”.

VICE CHAIRMAN TOLLISON made the MOTION to approve the thirty thousand dollar (\$30,000) administrative fee with COUNCILMAN PITTS SECONDING for discussion.

VOTE 5-1 (Councilwoman Anderson was in opposition).

**PUBLIC COMMENT** – Chairman Wood opened the floor for public comment at 6:00 P.M.

- 1.) Mr. Calvin Whitmire of Bridging the Gap appeared before Council saying the Agency is a non-profit agency, with a Board and asked for consideration of funding during the budget deliberations.

Chairman Wood stated that Council had decided to not fund this agency this year due to this being a tight budget year for the County.

Having no one wishing to address Council, Chairman Wood closed the session at 6:10 P.M.

Chairman Wood reported of a recent segment on the local WLBG radio station with House Representative Mike Pitts where he stated that over four hundred thousand dollars (\$400,000) had appeared in the State Budget. Chairman Wood said that the funds represent the Local Government Funds that the State has not given back to the Counties of South Carolina.

**CANCELLED - EXECUTIVE SESSION** – As per Administrator Segars, the executive session was no longer necessary.

**ADJOURNMENT** – With no further action required by Council, Chairman Wood adjourned the meeting at 6:10 P.M.
