Subject: please Help

My daughter Elizabeth G. Caulder back in July 2014 and her abusive boyfriend Jessie R. Bourgoins got their little girl Allison G. Bourgoins taken away cause they was on drugs. . After that My daughter straighten up her life and went to all the drug classes dss wanted her to go to. She got her own place and has a job. all her bills paid for. She pass all her drug tests. On Nov 2014 Elizabeth got her 2 year old daughter back. On the paper she got from DSS stated that if she pass all her home inspections and random drugs test that May 14, 2015 they will close the case.. On that day May 14, 2015 her DSS case worker Vicki came out and took pictures and congratulated my daughter on passing everything and let her know that her case was going to be close.. My daughter ex boyfriend who has a police record for lots of things and 1 is beating my daughter up. Came to her trailer and made threats against her even beat her. My daughter was scared and didn't say or do anything. Jessie would hide when anyone would show up so know one would know he was there. On June 7 2015 my daughter work a hour more then scheduled and my husband Tommy Shackelford took her home to discover Jessie went nuts over Elizabeth working a hour more and smashed her new TV she was still making payments on from Rent a center. Jessie then hit Elizabeth in the Head and said he was going to kill her. My husband saw n heard all this and stop Jessie. He got Elizabeth and my granddaughter Allison in the car.. Jessie screamed out if U call the cops I will make sure DSS will take Allison from you.

When they got to my house which is about 2 miles down the road we called the police. When the police got here and took my daughter to her trailer to get her stuff Jessie already broke all the windows but 3 out of the trailer and even took a dump on the floor.. He ripped up Elizabeth's clothes. We packed what we could in the car and left. CDV charges was put on Jessie.. The police didn't find him until June 9th when Me and my husband was taken our son who works at South of the Border which is also where both my daughters works at. and we saw Jessie walking with a friend heading to the shop my daughter Elizabeth works at. I called security and the Dillon County Police. S.O.B security Timmy Townsend held Jessie there till the police arrived. Jessie went to Jail.

On June 16, 2015 Jessie got out on bond. Part of that Bond is No Contact.. within mins of him getting out he texted my daughter saying "Im Back" Then more text and voice messages for him. He made threats to beat my daughter. Called her a nigger being we found out last year I am 29% Black.. Jessie also text saying he will get revenge on Elizabeth.. We again went to the police for all this. They made a report and again arrested Jessie June 24, 2015.. On June 30th, 2015 Jessie once again got out on another bond.. This time here him and his mother Christy Bourgoins went to the DSS office.. Jessie's Mother and Grandmother Janice Bourgoins are good Friends with both Denise Willington and Mr Huff.. Sure enough DSS came looking for my daughter even went to her Job on July 2nd, 2015.. I called the head of the Dillon DSS Karen English to find out what was going on because Elizabeth's case was suppose to be close and according to the paper work it said the same.. Mrs English thought the same and had no idea but would find out and call me back. The next day Mrs English called to tell me that my daughter Elizabeth's case was not closed because Mr Huff wouldn't sign off on it. I asked why and they had no answer.. I told Mrs English !st. There is no written letter or anything stating why Elizabeth's case would stay open and 2. Elizabeth and my granddaughter moved to NC where Jessie can't find them.. All Mrs. English would say is Mr. Huff wants Elizabeth and Allison at

the Dillon, SC DSS office in 30 mins.. I told her NO. That by law being my daughter has proof her case would be close May 14, 2015 and also being they now live in NC they don't have to cross state lines.. Mr Huff asked for Elizabeth's address which I called back and left Elizabeth's address on Mrs. English voice Mail..

On July 14th 2015 both my daughter Elizabeth and my husband had to go to court for Jessie breaking his probation. Jessie was a no show. His probation officer told my daughter that is automatic guilty and was going to issue a warrant on him. But Magically DSS officer Vicki was there and grab my daughter asking her for her address and told her that when she has time to come to the office. It was told that Jessie called DSS and them where my daughter was at. . So my daughter went back to work. a Few hours later I talked to Jessie's probation officer and she told me Jessie was waiting at her office when she got back from court so she was just going to make another court hearing for Aug 10th, 2015.. I asked what about today him not showing up, she said nothing except telling me that Jessie breaking his probation is different then other laws and has to worked differently.

Everytime Jessie gets in trouble with the Law his mother and step father Terry Morris call in favors to people they know in Dillon SC to get Jessie out of it. Jessie even wrote over \$3000 worth of bad checks on his great grandmother Mrs. Cook and all he got was 14 days chain gang and 5 years probation.. All Jessie ever gets for the crimes he does is a little bit of chain gang then he is back on the streets again.. Just like Jessie's mom called in favors for her other son who at the time was 16 Terry Morris Jr for raping their 10 year old cousin. All he got was 2 months in Juvenile Hall until he turned 17. Now he is also free..

As far as Mr Huff goes. I have a pass with him. Years and years ago my ex would call DSS saying I was hitting my son. He would do this everytime he got arrested for child support.. I was always found no guilty. After the 8th time I got sick of it and told Mr Huff just to take me to court, which he did.. Mr. Huff had NO evidence and I had my oldest son's DR's and teachers with me. I represented myself in court.. The Judge told Mr. Huff and the rest of DSS that was in the court room with him to NEVER bring me to court with NO Evidence.. I know Mr.Huff lost his promotion he was hoping to get and has had it in for me since.. The ONLY thing I have Ever been found Guilty on was DUS..

But back in Nov 2014 Mr Huff had my daughter sign a paper saying I was not allow to babysit or be alone with my granddaughter Allison being I had prior cases with DSS.. I guess since Now Mr. Huff is 2nd in command he can do what he wants.. My daughter did sign the papers because all she wanted was her daughter back, she didnt know Mr. Huff was breaking the Law..

Dillon, SC is so corrupted that its who know in Dillon that gets you places know matter what you do..

I am asking and Begging for HELP in all this...
