
This letter is a request for access to the public records listed below pursuant to the S.C. Freedom of Information Act. I would like to review the following:

1. Executed copy of the Non-Emergency Transportation Contract between South Carolina and American Medical Response, Inc. and/or Access2Care (the "NEMT Contract"), including all executed amendments and attachments;
2. All documents evidencing, referring or relating negotiations or discussions between AMR and South Carolina relating to the NEMT Contract after the execution of the NEMT Contract;
3. All documents evidencing, referring or relating to default or termination notices issued by South Carolina or AMR under the NEMT Contract;
4. All requests for additional compensation or any other concession made by AMR under the NEMT Contract;
5. All documents evidencing, referring or relating to any claims asserted by AMR or South Carolina arising under the NEMT Contract or its termination;
6. All documents, evidencing, referring or relating to any settlement or resolution of claims or disputes arising under the NEMT Contract including, without limitation, any agreement to treat the termination as one for convenience rather than for cause or default;
7. All documents evidencing, referring or relating to the reasons why AMR will transition its NEMT brokerage services to a new broker designated by South Carolina;
8. All documents evidencing, referring or relating to any claims made or contemplated by South Carolina against any bond, letter of credit or other collateral posted by AMR to secure its bid, payment or performance under the NEMT Contract;
9. All documents evidencing, referring or relating to complaints made about AMR by Medicaid members, transportation providers; and
10. A copy of AMR's proposal submitted in response to the RFP for the NEMT Contract.

Dear Ms. Wilson:

The enclosed CD contains the responses to your FOIA that we were able to assemble in accordance with your time constraints. They are:

- 1 & 10: The RFP and the proposal together make up the contract. See the RFP item VIIA for contract documents and precedence information.
- 2, 3, & 4: Hard copy documents have been included, but e-mails have not yet been searched, and one letter dated 9/16/2011 has not yet been located.
- 5: The e-mails related to this have not been pulled, but item #2 is partially responsive.
- 6: At this time, no such documents exist.
- 7: See items 2, 3, & 4, above.
- 8: At this time, no such documents exist.
- 9: We believe that this will take considerable time to pull. We estimate about a month will be needed to extract the documents and redact them of personally identifiable information.
