SECTION 1: The Minutes for the meeting of September 15, 1994, copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: The Minutes for the meeting of September 29, 1994, copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 3: The Commission unanimously passed a motion authorizing the Department to provide grant funding to South Carolina State University for a two-day preventive maintenance workshop for transportation providers in South Carolina, at an estimated cost of \$15,396.00, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion revising the June 7, 1994 allocation of Federal and State Mass Transit Project Funds, as shown in detail in the Appendix.


SECTION 5: The Commission unanimously passed a motion approving the action of the Department in extending existing bituminous retreatment contracts to include additional resurfacing work, as shown in the Appendix.

AGREEMENT WITH SOUTH CAROLINA STATE UNIVERSITY

It is recommended that the SCDOT Commission authorize the DEPARTMENT (SCDOT) to provide grant funding to South Carolina State University to plan and conduct a two-day preventive maintenance workshop for transportation providers in South Carolina. The maximum grant award of \$15,396 is requested to be made available through existing authorized Federal Transit Administration's (FTA) Section 18/Rural Transit Assistance Program (RTAP) 100% federal funding.

The two-day hands-on workshop will demonstrate the reduction of maintenance costs through innovative practice in pre/post trip analysis; optimize systemic scheduling of maintenance and early problem detection; explore efficient use of shop resources through inventory control and appropriate tracking; provide guidance in developing comprehensive preventive maintenance programs which minimize the total cost of planned and unexpected repairs and replacements, as well as consumables, and create a better understanding of the consequences/benefits of preventative maintenance.

**EXTENSION OF BITUMINOUS RETREATMENT CONTRACTS
TO INCLUDE ADDITIONAL RESURFACING WORK**

It is recommended that the Commission approve the action of the Department in extending existing bituminous retreatment contracts to include additional resurfacing work as follows:

Dorchester County:

Contract of L-J, Inc. - File No. 18.10941 - extended to include resurfacing (File No. 18.10941) of 0.24 mile on Road S-28-269 from S-18-267 (Dogwood Circle) to S-18-264 (Azalea).

Estimated Cost of Extension \$ 3,595.20

Williamsburg County:

Contract of APAC-Carolina, Inc. - File No. 45.10941- extended to include resurfacing (File No. 45.10941) of 0.14 mile on Road S-45-415 from US 52 TO S-45-412.

Estimated Cost of Extension \$ 4,876.22
