Gentlemen:

We are the accountants for Skip Hoagland and his company, Domains New Media, LLC. He has engaged us to file several whistle blower claims with the Internal Revenue Service citing that various chambers of commerce and convention and visitors bureaus are in violation of certain income tax regulations. The primary violation stems from the chambers and CVBs engaging "in activities normally carried on for profit" and for "providing particular services for individual persons." (see attached)

Mr. Hoagland has asked me to contact each of you to ask you if the local chambers or CVBs are competing directly with you in violation of these regulations. It appears most chambers and CVBs are in fact competing with media companies while receiving government funding and benefiting from both tax exempt status and preferential Google rankings.
