Regular Council Meeting  
6:30 PM

County Council met in regular session, in the Auditorium, County Administration Facility, with Chairman G. Neil Smith presiding. Agendas, bearing date, time, and location of meeting were mailed to Council members and local news media on January 14, 2012.

**WELCOME AND CALL TO ORDER:**

Chairman Smith called the meeting of January 23, 2013 to order and welcomed those in attendance. Councilwoman Jennifer H. Willis gave the Invocation and Pledge of Allegiance.

**PUBLIC FORUM:**

Chairman Smith opened the Public Forum and requested the Clerk to introduce the speakers who have signed up.

Junius Smith – Mr. Junius Smith spoke about the many legal issues as it relates to the Pickens/Easley rails to trails project. Mr. Smith stated he has attended several meetings including meetings with the Town of Pickens and City of Easley. Mr. Smith stated these projects are expensive to the tax payer, and the trails have proven a nuisance in Greenville County SC with problems of vandalism and theft along the borders.

Weldon Clark- Mr. Clark thanked Council for keeping taxes low, and further stated he appreciated the current sitting Council. Regarding the rails to trails project, Mr. Clark stated it was his understanding that some of the property owners along this trail are owners of the railroad that borders their property due to the fact that once the railroad does not function anymore; the said property reverts back to the citizen. Either way, Mr. Clark agreed this issue has many legal battles.

**APPROVAL OF MINUTES:**

- Motion was made by Councilwoman Jennifer H. Willis and seconded by Councilman Jeff Martin to approve the minutes of December 3, 2012 and January 7, 2013. Motion was approved by a unanimous vote with Councilman Randy Crenshaw abstaining from the December 3, 2012 meeting due to him not being on council at that time.

**ADMINISTRATOR'S REPORT:**

Mr. Hurst updated council on the following items.

- 1) Six Mile Fire Department. This department is complete and an open house will be scheduled for February.

- 2) Pickens Fire Department – Parcels of property have been procured for fire stations in Pickens. As previously discussed, one property is on Fox Squirrel Ridge, and one is on Highway 8. Permits are now underway.
- 3) Stormwater Permits - New regulations regarding stormwater permitting is requiring rain gages and a lock box for plans on construction sites. Mr. Hurst stated that staff is reviewing documents and finding out that certain locations that are serviced by weather stations will not require rain gages, but locations in the rural areas will require them. Mr. Hurst stated he will keep council informed as staff learns more about these new regulations. DHEC should be holding a breakfast/lunch meeting in March to address many of these new requirements.
- 4) Rocky Bottom and ISO Ratings- Land has been secured at Rocky Bottom for the fire station. Mr. Hurst stated he will be back to council as this item progresses. Also, Mr. Hurst noted that staff is applying to ISO for an 8 rating instead of a 9.  
Regarding ISO rating in general, Mr. Hurst stated there were also issues that need to be worked on as it relates to the actual dispatching of all fire calls. Mr. Hurst stated the way current fire calls are toned out by dispatch has an impact on ISO rating. Mr. Hurst stated he would like to address this further in planning sessions.
- 5) Duke Energy Nuclear Exercise- The Emergency Operations Center (EOC) staff received the written report from Federal Emergency Management Agency (FEMA) relating to the graded nuclear exercise. Mr. Hurst stated the remarks made about the performance of Pickens County were excellent. The EOC staff is now working on exercises that pertain to Pickens County and the safety of the citizens in events such as natural disasters. Technology is also going to be a major factor in future events as Google Earth and other “real time” software can be utilized. Mr. Hurst stated he appreciated the many volunteers that make the EOC a success.
- 6) Mile Creek Park- Grants have been secured at Mile Creek Park for the boat ramp and beautification. Mr. Hurst presented several pictures showing the many improvements at the park.
- 7) Hagood Mill- Grants are secured for the walking trail and bathrooms at the mill. Permits have been approved and these projects will move forward. Work is still being done toward the theater as well.
- 8) Clemson extension –Grants have been secured for healthy lifestyles education. In addition, a naturalist grant has been secured to teach youth about sciences of natural resources. The County funds the extension office, and Mr. Hurst stated he thought it important to let the public know what these agencies are doing in the community.
