Dear Ms. Susan Dean, Carolyn Roach,

As requested enclosed are my Fathers bank statements, the attorney that handled the sale of his home is named James Haroutunian, telephone number 978 671-0711. I have also enclosed the copy of the Funeral home my father prepaid services for in Massachusetts . Feel free to reach out to all of them in your interrogation. I have also enclosed just some of the bills that are piling up while this investigation continues.

In 1977 My mother and Father divorced. That is the last year I lived with my father. He went on to remarry and had 4 step children. In 2010 his second wife died suddenly and unexpectedly . He continued to work and live alone in the house. At some point he had to put his house up for sale because as he told me there were two mortgages on it and because he was too depressed to care about much of anything he had not paid taxes or bills. So I let him stay with me in my spare room in Waltham Mass, knowing that I was in the process of selling my house and moving to South Carolina , but that he could stay till then. Over the next six months my father had lots of serious health issues. During this time his car died and he said he could not afford to fix it, so from that point on I became the chauffeur for all doctors appointments etc. Both the stent in his heart and leg let go and had to be redone. Then Doctors put him on heart medicine that was considered the last option and was quite expensive, over \$300 out of pocket per month. Also I know he paid out thousands of dollars in doctors bills and copays. When it came time for me to move to SC in Feb-Apr of 2012, my Dad stated he wanted to come, so I took him with me because no other family member offered him a place and he was not ready to live in a nursing home. In November of 2014, with his physical needs increasing to more than I could handle physically, I found a place my Dad could afford as he had no long term care insurance, the only option, due to finances, was the Veterans Victory House in Walterboro, SC, where he is being treated under hospice . This past August after being diagnosed with bladder cancer they stopped his stent/heart meds as they would cause him to bleed out. The doctor and my father decided that due to his age and health they would not treat or remove the cancer. So needless to say he is only expected to live a short time now. But instead of being able to be with my father and offer him some comfort I spend all my free time trying to dig up his financial history for your interrogation!

This will be my last attempt at trying to get him on Medicaid. As I said I have been working like crazy to get him anything I would have hoped he would be eligible for since he contributed to Medicaid for over 65 years. I had at one time thought just maybe he could come home to the peace and comfort of his own bed to die but since I can't get him Medicaid I can't get help from Healthy Connections to make that possible. That breaks my heart. But if you people deem him unworthy there is nothing I can do except learn from it. There is apparently a war against hard working self sufficient Americans, while all of our resources are going to support illegal criminals with free food housing education health care and even Medicaid for all their children at birth! and now preference of employment over American citizens!

Any further information you need you can go visit my father at the Victory House in Walterbore, SC. Perhaps that would be a good field trip in humanity. maybe then you would be able to see first hand those you are so righteously denying !

I will just reiterate at this time That I am Ashamed of My Country and those that are running it into the ground! The Once Great United States! When Illegals can jump a fence and have several kids and they are all issued Medicaide cards at birth which take care of them instantly from birth, give them welfare and free college and food stamps while you put a man who worked till he was Eighty years old , Served in the Navy and National Guard the interrogation that you have been working on since May, six months now trying to find any reason not to help him. This has been an eye opening experience for me. Something I hope to write about after my fathers death!

I brought my Dad and myself here because I read so much about SC being a Great Place to retire, but I have found it to be a very unhospitable and ill prepared place for seniors. I was horrified by some of the facilities my father and I visited looking first for some day programs for him so I could get back to work and then long term care when needed. I sincerely think the state needs to either get up to speed with severely needed elder services for American citizens or stop touting it a great place to retire. Or be truthful and tell them they will need anywhere from 10-12 K a month for a descent nursing home. I have heard nightmare after nightmare from other near seniors trying to assist senior parents and finding the same lack of assistance and services. I have enough information to write a book on the "new" dos and donts involving parent care and what states will truly expect from you the care givers and the interrogation an American has to go through but an Illegal Mexican, Guatamalen or Muslim can come here get all free services work under the table have all the children they want and the states will provide all their needs and all the while they are at Western Union in Krogers shipping all the US money they make under the table in cash back to Mexico. That is just one scenario I have been told about and witnessed with my own eyes. Tell Nikki Haley not to go to the service desk at any supermarket three days after the first if she doesn't want to stand in a long line and watch the US Dollars people like my father contributed, leave this Country!

I have given this entire scenario to God because only He can help my father now. I studied Psychology and Sociology and now understand why such a high number of elders commit suicide I cannot imagine being my Dads age and trying to deal with all of this! It is just shameful! that at the end of their lives they are denied basic human services. But look at the Horror show we have with all our veterans dying waiting for Doctors appointments! Shameful. I do not envy anyones job that can do the above day in and day out. Denying our American citizens and veterans who have built this Great Country basic human needs while handing out everything to people who are in our Country Illegally. I am just curious how do you investigate what a criminal owns in foreign countries before handing out medicaid to them and all their children? God Help America!!
