Dear Fred:

The minutes of the February meeting of the Commission indicate (p.8) that "President Jackson suggested that the Commission meet with the chairmen of the governing boards in an effort to work out a reasonable solution."

Except for this somewhat tangential statement there is no indication that the institutional spokesmen present (including Dr. Borkowski and I) strongly opposed the recommendation that the control of the Commission over tuition and fees be extended to authority to set maximum and minimum fees. Since in other instances in which institutional representatives opposed proposed actions of the Commission this fact was noted (e.g., p. 2) the impression that the reader of the minutes receives is that there was little opposition from the institutions to the recommendation on tuition and fees.

I am sure that this omission was inadvertent and I am also sure that you would wish the minutes to portray accurately the actual discussion that occurred. If the views of institutional representatives are deemed of sufficient importance to be entertained it would appear that they would be sufficiently important to be noted in the minutes. If not, fairness would appear to dictate that they be consistently omitted. In this way we would have a ready response to our own constituencies when the Commission takes some action that the academic communities strongly oppose. We could either point to the minutes as evidence that we did indeed oppose the action or else indicate that the Commission never acknowledges our views.
