A CALLED MEETING OF THE ANDERSON COUNTY COUNCIL WAS HELD ON DECEMBER 15, 1986 AT 5:00 P.M. IN THE ANDERSON COUNTY COUNCIL CHAMBERS - ROOM 109. CHAIRMAN HAROLD E. BEEBE PRESIDED.

Ms. Mary Heaton, Greenville News reporter, also asked to be on record as opposing the executive session. Vote was 5-0. Mr. Beebe invited Mr. Ernie Garrison.

On the motion of Mr. Hooper, seconded by Mr. Wiles, Council voted unanimously to come out of executive session back into regular session at 6:35 p.m.

Mr. Cox moved that Greene, Lindley continue the audit in whatever direction and scope is necessary for the Road Maintenance Department in accordance with Generally Accepted Auditing Standards. Mr. Wiles seconded and vote was unanimous.

Council adjourned at 6:45 p.m.
