NASUAD's Senior Director Damon Terzaghi will present key themes and findings from the survey.

### **Lifelong Disparities Among Older American Indians and Alaska Natives**

The AARP Public Policy Institute and the International Association for Indigenous Aging released a report on the lifelong disparities that exist among older American Indian (AI) and Alaska Native (AN) populations when compared to the general United States population of older adults. The report includes a definition of who falls into the category of American Indian, identifies where these populations live in the U.S., and compares AI/ANs generally with the rest of the population of older adults and also specifically compares health coverage.

### **Dementia Care Coordination Workforce & Practices Report**

The University of California San Francisco published a report about dementia care coordination for dual populations with a specific look at the inadequate workforce of dementia-capable care coordinators. Effective care coordination is shown to improve the quality of life for patients with Alzheimer's disease and dementia. Currently, there are twelve states in the process of implementing demonstration projects. This report examined three-way contracts from seven states that were selected for their expertise in care coordination.

### **Medicaid & CHIP: September 2015 Monthly Enrollment Report**

The Centers for Medicare & Medicaid Services (CMS) released their monthly report for September 2015 on Medicaid and CHIP application, eligibility, and enrollment data. States provide data to CMS on factors related to key application, eligibility and enrollment processes using the Medicaid and CHIP Performance Indicator Project. The data is then used to inform CMS on the operations of the programs in each state and to share state performance data publicly. Data collection for this project began in October 2013. A key highlight showed that enrollment reached almost 71.6 million people for Medicaid and CHIP in September 2015.

## Final Rule for Extension of 90/10 Federal Funding Released

On December 3, 2015, the Centers for Medicare & Medicaid Services released a final rule on the Extension of 90/10 Federal Funding for Medicaid Eligibility Systems. This rule helps CMS to advance their goal of supporting states in the modernizing state eligibility systems. All of the changes will help states to improve customer service and develop better Medicaid eligibility, enrollment, and delivery systems through various initiatives. Additionally, new definitions for "Commercial Off-the-Shelf (COTS)," "open source," "proprietary," "service," "shared services," "Software-as-a-Service (SaaS)," and "module" are included in the final rule. The final rule has been published in the Federal Register.

## National Health Expenditures from 2014

On December 2, 2015, the Centers for Medicare & Medicaid Services's Office of the Actuary published the 2014 National Health Expenditures. A major finding from the report shows that the increase in spending resulted from the millions of new individuals receiving health care coverage under the Affordable Care Act and the growing costs of prescription drugs. Additionally, the report includes data on the total private health insurance expenditures, medicare spending, medicaid spending, out-of-pocket spending, and retail prescription drug spending.

## Supplemental Security Income & Spousal Impoverishment Standards Bulletin

On November 20, 2015, the Center for Medicaid and CHIP Services (CMCS) released an informational bulletin on the Supplemental Security Income (SSI) and Spousal Impoverishment Standards for 2016. Each January the Medicaid income and resource standards change based on the SSI federal benefit rate (FBR) and the Consumer Price Index (CPI). A chart with the new standards is included within the bulletin. Because there was no change in the CPI for Urban Wage Earners and Clerical Workers and the Consumer Price Index for All Urban Consumers, many of the standards will remain the same as they were in 2015.

## Proposed Annual Notice of Benefit and Payment Parameters for 2017

On November 20, 2015, the Centers for Medicare & Medicaid Services (CMS) released a proposed Annual Notice of Benefit and Payment Parameters for 2017. The rule proposes payment parameters and provisions related to the risk adjustment, reinsurance, and risk corridors programs; cost sharing parameters and costsharing reductions; and user fees for Federally-facilitated Exchanges. CMS's goal is to enhance the consumer experience during open enrollment and throughout the year. The proposed rule has been published in the Federal Register with a comment period. All comments must be submitted by **Monday, December 21, 2015 at 5:00 p.m. ET.**

## Kaiser Family Foundation

### **Issue Brief on the Variation in Medicare Part D Out-of-Pocket Costs**

The Kaiser Family Foundation released an issue brief that analyzes the cost of Medicare Part D drug plans, specifically out-of-pocket costs for Medicare beneficiaries. A major finding from the brief showed that Medicare Part D enrollees may pay thousands of dollars of out-of-pocket costs if they require a specialty drug, even after exceeding the catastrophic coverage threshold. This study's findings emphasize how important it is for beneficiaries to diligently shop for new plans each year during Medicare Open Enrollment.
