Please consider the following suggestions for change as you and other governors meet for the next National Governors Association meeting and move to make a government that works once again for Americans.


1. Require the Federal government to have a balanced budget just like the States.

3. The Federal government must be better stewards of our tax dollars. There needs to be complete transparency and accountability at all levels of the government concerning spending.
4. Reduce the size and scope of all branches, departments and agencies of the government. No part of the government should be allowed to act independently of Congress or violate the basic rights and freedoms of American citizens.
5. Require the Federal government to have a strong national defense with secure borders.
6. Simplify the income tax by changing to a flat tax system for individuals, businesses and corporations. The form for filing should be one page.
7. Elected positions should not be allowed to be career jobs. Term limits are needed for Congress and political appointees. Two four year terms for the House and one eight year term as a Senator.
8. All government employees are equal and should receive the same benefits. Being in Congress, or The President does not make you "special". Those who are elected, appointed or hired to serve the public need to do just that - serve the public and not be elevated to positions of privilege. Once their term ends, so do the benefits. The job ends just the same as for average citizens.

9. Americans must be afforded opportunities to be productive. Jobs and careers are what Americans need, not handouts and government dependence. The Federal government needs to protect and encourage American jobs, careers and business, in America.
10. We need to take care of America and Americans first. Start rebuilding the country's infrastructure.
11. The idea of all humans are created equal needs to be our guide. Eliminate all the special interest groups and just treat everyone the same. The average citizen's input should be as important as that of any corporate or political lobbying group. Political Action Committees (PAC'S) need to be eliminated.
12. Require personal responsibility and hold everyone accountable for their actions. Laws, rules and opportunities need to be applied equally. If it is a crime for the average citizen, it is a crime for the government official. One's race, age, gender, sexual orientation, wealth, and peaceful religion should not be used for a basis of applying the law. Ms. Justice must remain blindfolded.

The fall of the Roman Empire, The French Revolution, American Civil War, WWI, WWII, Korea, Vietnam, the 4000+ years of war in the Mid-east all resulted from corrupt governments not serving and protecting its citizens.
