Dear Representative Huggins

I am your constituent and a dialysis patient receiving dialysis treatments three times a week to stay alive. I am deeply concerned about the Centers for Medicare and Medicaid Services (CMS) proposal to slash the Medicare Ends Stage Renal Disease (ESRD) program. Dialysis is a lifeline for someone like me who has kidney failure. I need your help.

My dialysis facility has many of your constituents who are Medicare beneficiaries like I am. We rely on Medicare to pay for our 3- to 4-hour dialysis treatments as well as certain drugs, labwork, and other services. Deep cuts to payments will have a critical impact on all patients and the care we receive. Because I have several different medical conditions that complicate my health care, I rely heavily on the nurses and staff at dialysis clinics to monitor my conditions. These people help keep me out of the hospital.

Adequate Medicare funding is vital to provide quality care. Medicare payment already falls short of covering the cost of dialysis—cutting nearly 10% from the program is unacceptable and will hurt hundreds of thousands of people like me who depend on dialysis to stay alive.

Medicare has made a promise to protect people with kidney failure to, at a minimum, cover the cost of care. I need you to ensure that this cut does not happen.

Please protect people with kidney failure who depend upon dialysis treatments to live by making sure that the total payment amount for dialysis services is adequate to cover the cost of providing the life-sustaining treatments and implore CMS to do the same.

Dear Ms. Hudson:

The South Carolina Department of Health and Human Services (SCDHHS) received your letter sent to Representative Chip Huggins concerning the Centers for Medicare and Medicaid Services' (CMS) proposal to adjust reimbursements for the Medicare End-Stage Renal Disease (ESRD) program. We welcome the opportunity to be of assistance.

The ESRD proposed rule is intended to adjust the 2014 ESRD Proposed Payment System (PPS) base rate to reflect changes in the use of ESRD-related drugs and biologics. This proposed change is being implemented to adjust rates to more accurately reflect the cost of services that are included in the ESRD payment bundled rate. The drugs and biologics that are included in the bundle reimbursement rate for ESRD services change over time. If facilities are no longer using drugs currently included in the ESRD payment bundled rate, the compensation needs to be reviewed and adjusted to reflect the change in program service.

The SCDHHS understands the importance of having dialysis treatment services available to the citizens of the State of South Carolina and will continue to work with CMS on this very important issue.
