Good Afternoon Mr. Filali,

I do see the gap in the information. I apologize for not catching it. However I believe the gap is for 2014-2015 while Yancey McGill was Lieutenant Governor. Page 10 of the document I sent includes the information for 2013. I suspect the reason for the gap is because we pulled the information on the staff from the accountability reports and there would not have been one during the timeframe that Lieutenant Governor McGill was in office. I will have to work with staff to compile this information and it most likely would not be available until next week or possible after the new year depending on staff. I apologize for the gap.

As to your other question on changes in staff salary. To my knowledge there is no statutory increase to salaries year over year and salaries in the Lieutenant Governor's Office are discretionary within certain boundaries. However the Lieutenant Governor's Salary is set by a budget line item.
