Good afternoon. The South Carolina State Employee Code of Conduct took effect July 1, 2015, for cabinet agencies. All other agencies were encouraged to implement a code of conduct policy, but they were not required to do so.

Executive Order 2014-13 established the State Employee Code of Conduct Task Force, which issued a final report with recommendations August 7, 2014. Those recommendations were the basis for each cabinet agency's code of conduct.

The task force recommendations regarding use of social media state that "unless specifically required by the agency to perform a job function, you may not use social media, including but not limited to Facebook, Instagram and Twitter, while on duty or through the use of state resources or equipment."

The recommendations regarding use of social media were based on state employees exercising good stewardship of state resources; therefore, the recommendations did not address employees' use of social media outside of the workplace. Please see Rule 4 in the South Carolina State Employee Code of Conduct Task Force Final Report. You can access the report at the link
