

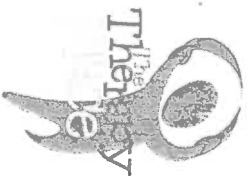

Dear Mr. Keck:

We received the letter denying our request to modify the Conductive Education grant to a holistic therapeutic design. I am writing to the Council in an effort to explain what happened because I'm not sure that you understand why the change was made or how this modification is so slight and is, in fact, so similar to what we were already doing.

First of all, the Conductor was not providing the program as we intended and as we had come to understand that Conductive Education was intended. It was our understanding that Conductive Education was a model that involves a multiple therapeutic approach (gross motor/fine motor). The Conductor that we had employed had a single-minded approach that had turned into a solely gross-motor program. There were also personal confrontations that she had with our therapists that could not be overlooked. We made the difficult decision to let her go. After doing so, we revisited the goals of the program and the grant and realized that with our staff of excellent therapists, we could provide the program as it was intended in the grant and just change the name. The grant was intended to provide therapeutic interventions (call it Conductive Education if you need to) to encourage independence through gross and fine motor development. Now, we have also added communication, educational centers and reinstated the feeding component. This is the program that we are now providing, not with a Conductor, but with four highly trained, specialized, licensed therapists rather than a single person that was supposed to be providing it all-in-one - but wasn't. It is now MORE innovative than before and it is of a more clinical nature as well. The students from the Exercise Program now have a clinical program to participate in. Their professor had denied their participation stating that the students needed to be supervised by licensed therapists - now they are!

This decision wasn't made lightly and it wasn't what we would have envisioned had there not been significant problems with the Conductor on staff. However, it ended up being the right decision. Our Bridges Coordinator will finish her masters in special education in May. She meets with the parents on a regular basis and coordinates the therapies and educational centers for the children. We are so fortunate to have found this direction for our program and I know that the DD Council would be proud to have their name associated with it if only you would look a little closer.

I am hoping that you will consider this letter as an appeal, if that is even an option. I invite the Council to come take a tour and see for yourself the progress these children are making in the environment that has been created through this grant. We are asking that you reinstate the grant as the Bridges Program and continue funding through June 30 and honor a 3rd year continuation grant as well.

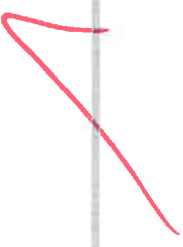


