Gov. Nikki Haley will hold her annual press conference this morning to discuss vetoes she has made to the \$7.5 billion state budget. Haley announced her vetoes last year shortly before the July 1 start of the fiscal year due to drawn out budget deliberations by lawmakers over additional money. Despite additional money this year, there was no continuing resolution needed as the budget sailed through the House and Senate before being ratified a week ago. Last year, Haley issued 87 vetoes totaling \$30.2 million. It was a higher than the \$18.5 million she vetoed in 2014 and significantly lower than in prior years when she's vetoed as much as \$94 million.

She made an impressive mark in a mostly male legislative body. Then she became the first woman to win a major-party nomination for the chief executive job she sought. How about that Nikki Haley? From her first inaugural speech on Jan. 12, 2011: "My mother was offered one of the first female judgeships in her native country, but was unable to serve on the bench because of the challenges of being a woman in India. Now she sits here today watching her daughter become governor of South Carolina, the state she proudly calls her home. When you grow up with a mom like that, the word 'can't' is not in your vocabulary." And even if you can't accept — yet — that Hillary Clinton will be our nation's first major-party presidential nominee, here's reassuring evidence that putting a woman in charge can work out well: Marvel at the grand force of right-wing nature that was Britain's only (so far) female prime minister, Margaret Thatcher, who served longer (1979-1990) in that job than anyone else during the 20th century.

**Note:** Haley, though far below Thatcher's exalted conservative-icon status, is also a fiscal hawk. Our woman governor has even dared to take on the good old General Assembly boys in this legislatively dominated state, riling them anew by backing some challengers to incumbent Republicans in next Tuesday's primary.

Gov. Nikki Haley on Wednesday signed legislation approving billions of dollars for road projects across the state, but she wasn't happy about it. She says reform measures in the legislation approved by lawmakers don't go far enough. "I have done so for one reason and one reason only," Haley said of the roads bill, "it is a better option than what we will have without this bill: a full reversion to the even more unaccountable and defective system that was replaced in 2007." Haley had until midnight to either sign, veto or let the bill become law without her signature. The governor also signed into law a bill to forgive \$12 million worth of state loans for South Carolina State University and create

a repayment plan for a \$6 million loan.

Gov. Nikki Haley reluctantly signed legislation Wednesday that will let the state borrow \$2.2 billion to jump-start improvements to South Carolina's deteriorating roads, saying she did so only because its so-called reforms are better than nothing. The Republican governor said the law provides a step forward in highway funding and marginal improvements to the Department of Transportation's governance. "To claim this law as anything close to a victory, to represent it in any way as a true solution to our infrastructure problems" would be deceiving the public, she said in a letter to legislative leaders she sent along with the signed law.

Gov. Nikki Haley signed a \$4 billion road and bridge spending plan Thursday that includes repairing Malfunction Junction in Richland and Lexington counties. The proposal also includes replacing nearly 400 bridges and giving the governor more control of the state Transportation Department. Still, Haley expressed disappointment in the proposed changes for restructuring the Transportation Department commission. "So let us all be honest about what we accomplished in this bill: incremental and incomplete reform, or put a different way, far less than the people of South Carolina both expect and deserve from us," she wrote in a letter to lawmakers.

Gov. Nikki Haley approved billions of dollars for road and bridge projects across the state Wednesday even though she said reform measures in the bill that took lawmakers years to pass don't go far enough. "I have done so for one reason and on reason only—it is a better option than what we will have without this bill: a full reversion to the even more unaccountable and defective system that was replaced in 2007," Haley said in a rare signing statement. "This bill does move South Carolina marginally forward by replacing General Assembly selection of the Transportation Commissioners with gubernatorial appointment," Haley wrote. "But let's be clear that 'progress' is little more than window dressing. The process for confirmation and removal of commissioners is deeply flawed."

Gov. Nikki Haley is ceremoniously signing a law that bans most abortions in South Carolina at 20 weeks beyond fertilization. Supporters are celebrating the law Wednesday at a Christian school in Greenville County that caters to children with disabilities. The law took effect with the governor's

signature two weeks ago. The ban's only exceptions are if mother's life is in jeopardy or a doctor determines the fetus cannot survive outside the womb. Its definition of "fetal anomaly" makes it illegal to abort a fetus with a severe disability if the child could live. Such anomalies are generally detected around 20 weeks.

Gov. Nikki Haley traveled to a Christian school for children with disabilities to re-sign a new state law that bans abortions at 20 weeks of pregnancy, holding the ceremony in the heart of the conservative Upstate. Haley said she did not bring this second and more symbolic bill-signing to the Greenville area because abortion is so political. Instead, she said, it's because she's a mom. "I'm not pro-life because the Republican Party tells me," Haley said. "I'm pro-life because all of us have had experiences of what it means to have one of these special little ones in our life."

Gov. Nikki Haley held a ceremonial signing ceremony for a recently-passed law that would ban abortions at 20 weeks, which bill sponsor Rep. Wendy Nanney said was just the first step in the effort to chip away and eventually overturn abortion rights in South Carolina. "We are at 20 weeks and we're going to keep pushing," Nanney said at the ceremony held at Hidden Treasure Christian School, a religious school for children with intellectual and physical disabilities. The law bans all abortions at 20 weeks or later and makes no exceptions for rape or incest. The only case in which an abortion can occur past 19 weeks in South Carolina is when the fetus will die or the health of the mother is threatened. Doctors who violate this law could be jailed.

South Carolina State University is officially free of \$12 million in state loans, but it must repay a separate, \$6 million loan over the next 16 years. Gov. Nikki Haley signed the terms into law Tuesday without fanfare. The law forgives \$8 million next year, then \$2 million each in the following two years, provided SC State's finances keep improving. The university must make yearly payments of \$355,000 on the other loan. State officials approved both loans in 2014.

South Carolina's top Democrat is calling on elected Republicans to rescind their endorsements of Donald Trump, saying Wednesday that the presumptive GOP nominee is a racist and xenophobe, in part due to his race-based attacks on a Hispanic judge. During a news conference, party Chairman Jaime Harrison said that, while he respects Republicans and their party, he doesn't understand how officials including Gov. Nikki Haley can condemn Trump's divisive rhetoric, yet say they still feel he's the best choice to be president. "To say these types of remarks, and then constantly defend them, is disqualifying for a presidential candidate, period," Harrison said, adding that a President Trump would put the country "in peril."

A pair of bills with identical language has been introduced into each chamber of the U.S. Congress in joint opposition to the Department of Labor's rule to change employee classifications and broaden the scope of overtime pay. The bills are companion bills called the Protecting Workplace Advancement and Opportunity Act in both the House and Senate. Rep. Joe Wilson, R-S.C., said, "Companion bills promote simultaneous consideration of a topic or issue of interest to members of both the House and the Senate. It leads to a greater chance that the legislation will be passed before the end of the Congressional term, which is why it is so significant that this legislation to negate the overtime rule has companion legislation already introduced in the Senate." The bills aim to nullify the Labor Department's rule change which was made official in late May and is currently set to become effective Dec. 1.

State Ethics Commission filings show Leatherman had \$1.2 million on hand as of late May after spending \$400,000 in the past two months, mainly on television advertising. The disclosure shows the 35-year Senate veteran's campaign is concentrating on his main challenger, former Florence County GOP Chairman Richard Skipper, ahead of Tuesday's GOP primary. After a strong fundraising pace earlier this year Leatherman saw increased support from Charleston-area donors who collectively gave more than \$35,000 — the most coming from any region in the state during the April and May reporting period.

NORMALLY, RICK Hubbard would be the hands-down choice in the race for solicitor of the Lexington County-based 11th Judicial Circuit. He’s a career prosecutor with far more courtroom and managerial experience than his opponents, a person who was in charge of day-to-day operations when the elected solicitor was, to put it kindly, not particularly engaged, and he was being groomed to take over one of the top prosecutorial posts in the state. But there’s also this: The elected solicitor he worked for was Donnie Myers. Mr. Myers was known equally for sending killers to their death and for bending and sometimes breaking the rules to get those death sentences. Mr. Hubbard worked for Mr. Myers for 22 years, while Mr. Myers let defendants languish in jail before they were even tried, and too often forced appeals courts to overturn guilty verdicts, which in turn forced families of victims to endure a second excruciating trial.

Charleston police arrested nine people and confiscated more than \$150,000 worth of drugs, \$214,000 in cash and seven guns

during a six-month probe that officials tied Wednesday to the shooting death of Patrick Moffly. Among the haul were 43,000 Xanax and synthetic marijuana pills, 1.5 pounds of cocaine, 5 pounds of marijuana, ecstasy and LSD. Most of the drugs were packaged on a table at the Charleston Police Department next to two military-style rifles as the officials announced the fruits of their investigation Wednesday. They also seized four cars. "We've certainly seen an increase in violence in our community, as well as other cities around the country," Police Chief Greg Mullen said during the news conference. "One of the things that we wanted to do is to demonstrate ... the level of connection between narcotics, weapons and violence."

A drive-by shooting early Tuesday in Jackson turned into a net of approximately \$300,000 worth of fresh-cut marijuana plants. "This investigation has developed into a multi-jurisdiction drug case spanning across two states," Sheriff Michael Hunt said in a news release. "As a result of this ongoing investigation we have disrupted a major marijuana trafficking ring and we will hold the violent suspects involved accountable for this disruption in our community." Around 6:43 a.m. Tuesday, the Aiken County Sheriff's Office, the Jackson Police Department and EMS responded to the 18000 block of Atomic Road in Jackson for a shooting incident, where two male victims were transported to the hospital for gunshot wounds.

The Florence County Emergency Management Division conducted its first Community Emergency Response Team (CERT) training over the weekend to educate volunteers on how to help in the event of a disaster. Twelve volunteers attended the three-day training program that started June 3. They learned about basic firefighting, medical response, search and rescue tactics and incident command. Personnel from Howe Springs Fire Rescue, Florence County Emergency Medical Services and Florence County Emergency Management taught the courses. The nationwide CERT program is an official emergency preparedness program of the Federal Emergency Management Agency (FEMA). The CERT concept was originally developed and implemented in 1985 by the Los Angeles Fire Department following a series of earthquakes in both the U.S. and Mexico. Those events left hundreds dead and injured and without emergency services.

Orangeburg City Council has delayed action on an ordinance that would force bars to close early after hearing from owners who say the change would hurt their businesses. "As a taxpaying business, as a law-abiding business, all I'm saying is look at us as just businesses," Aaron Gillespie of Cloud Nine said to city council Tuesday night. "There's no other businesses in Orangeburg required to close their doors. None," he said. The ordinance would prohibit the sale and on-premise consumption of alcoholic beverages in commercial establishments during the hours of 2 a.m. and 6 a.m. The county approved a similar ordinance last year.

The world's largest retailer is ending its ad-matching policy Thursday at 500 stores, or nearly 11 percent nationwide, including all 14 in the Charleston area. Wal-Mart began rolling back prices in early May at select stores so that price-matching is no longer necessary, according to spokesman John Forrest Ales. "It's our responsibility to offer prices on the shelf customers can trust," he said. Two weeks after their apartments were condemned, some residents of the Park Place complex in Spartanburg are no closer to finding a permanent place to live. Brothers Timmy and Delmetre Mitchell had lived at the complex at 84-88 W. Park Drive for nearly eight months before they were forced to leave their bug-infested, decrepit apartment on May 25. They have temporarily moved in with their sister, Michelle Carson. Delmetre Mitchell said living with his sister has gone well so far, but eventually he wants to be back in his own place. "It hasn't been too hard. She's doing all she can do," he said.

Next year's funding for the Clemson Area Transit service around Pendleton faces a \$25,000 shortfall. Town Administrator Steve Miller told the Pendleton Town Council Monday that he and CAT officials are looking for ways to maintain the town route, which costs \$185,000 for the budget year that ends June 30. Tri-County Technical College chipped in \$10,000 for this year's CAT service around Pendleton, and the rest of the \$185,000 came from Clemson University (\$15,000), the Town of Pendleton (\$30,000), Villages of Town Creek (\$30,000) and CAT itself (\$110,000). Tri-County spokeswoman Rebecca Eidson said CAT didn't ask for money this year.

For the third consecutive year, Clemson's group of NFL Draft selections have collectively surpassed \$20 million in guaranteed salaries on their rookie contracts. The Tigers produced nine picks in the 2016 pool, the second-most in the country and second-most in school history. Eight of the nine Clemson products have signed their four-year contracts, which top \$35 million in potential base salaries spread over the length of the contracts, \$20 million in guarantees and \$11.6 million in signing bonuses, according to the NFLPA's draft report. Clemson's 2014 and 2015 classes also surpassed \$20 million in guarantees, led by Bills receiver Sammy Watkins' \$19.9 million deal in 2014 and Falcons linebacker Vic Beasley's \$14.5 million deal in 2015.

On the verge of endorsing Hillary Clinton, President Barack Obama will pay tribute to Bernie Sanders' historic candidacy for presidency with an Oval Office meeting aimed at unifying the Democratic Party for a general election brawl with Donald Trump. Sanders, the runner-up for the Democratic nomination, was heading Thursday to the White House under intense pressure to drop out and clear the way for Clinton. Though he showed signs he understood the end was near — he was laying off about half his team — he vowed to keep fighting for his movement, which Democratic leaders hope will evolve into a new base of support for Clinton. Obama, who was expected to formally endorse Clinton following his midday meeting with Sanders, has sought to give the Vermont senator the courtesy of exiting the race on his own terms. On "The Tonight Show Starring Jimmy Fallon" on Wednesday night, he praised the Sanders campaign.

Associated Press: Israel beefs up troops in West Bank after Tel Aviv shooting

Israel on Thursday imposed a series of sweeping restrictions on Palestinian movement and deployed hundreds of additional troops to the West Bank in response to a Tel Aviv attack that killed four Israelis. The shooting, carried out by two West Bank Palestinians, targeted a crowded tourist and restaurant district in the heart of Tel Aviv and was among the deadliest and most brazen attacks in a nine-month wave of violence. The area is located across the street from the Israeli military's headquarters. As Prime Minister Benjamin Netanyahu prepared to meet with his Security Cabinet to discuss further responses, the Israeli military announced that it was deploying two additional battalions to the West Bank "in accordance with situation assessments." The deployment, involving hundreds of troops, includes soldiers from infantry and special forces units.
