Austin - as a general rule, I have attended each of these when I was invited by a member of

the legislature. There has not been enough time available to go to every meeting personally. That said, we have been very good at having part of the team present for representation. My role has almost exclusively been "expectation management". Many local politicians are "over-promising" and I am doing the math to demonstrate that what is being promised, may not be physically possible (in the case of a recent town hall with Reps Huggins and Quinn, I polled the crowd to find out that 40 families present had been "promised" buy-outs. The average price of the home was \$150K. The cost to buy out just this small portion of Lexington would cost the HMGP about \$6M, leaving less than \$4M for the rest of the county / rest of the state). Based upon our vulnerability analysis, there was probably not anyone in that crowd that would have received any of the HGMP money). I generally tell them what they need to hear, instead of what someone promised them.

Happy to go if you or a member of the legislature would like me to go,
but want to ensure the squeeze is worth the juice. If I go, I will
have to leave immediately following our Thursday meeting with DOA.
