Mr. Poore called the meeting to order and Councilman David Hooper gave the invocation.

On the motion of Mr. Wiles, seconded by Mr. Hooper, Council voted unanimously to approve the March 6, 1980 minutes as mailed.

Mr. David Watson discussed sealed bids for corn, fertilizer and others. The low bidder was Pendleton Oil Mill for \$5,695.00. He also discussed sealed bids for ammonium nitrate for \$9,441.25 from Kaiser Agricultural Company which was also the low bidder. On the motion of Mr. Rhodes, seconded by Mr. Wiles, Council voted unanimously to go with the low bidders on both bids.

Mr. Watson presented sealed bids for Lufkin measuring tapes for the Assessor's office. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to go with the low bid which was from White Jones for the amount of \$1,596.94.

Mr. Watson presented third and final reading for Ordinance #49 (Amendment to the 1979-80 FY Budget). On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted unanimously to adopt on third and final reading Ordinance #49.

Mr. Mike Mullinax presented County Council with Resolutions #105 and #106 regarding the annexation of two certain tracts of land into the Homeland Park Water District. On the motion of Mr. Rhodes, seconded by Mr. Wiles, Council voted four in favor to adopt the Resolution. (Mr. Wright abstaining.)

Mr. Mike Mullinax asked Council for approval of a special tax district for Loblolly Pines. On the motion of Mr. Gerrard, seconded by Mr. Wright, Council voted unanimously for Mr. Mullinax and the County Attorney to get together and begin the work.


Mr. John Rogers representing the West Pelzer Cable TV which is presently negotiating with West Pelzer to furnish the area with Cable TV appeared before Council. He needs a County franchise in order for business to get underway. Mr. Poore advised Mr. Rogers to get with the County Attorney and get an Ordinance drawn up and to be present at the next meeting.

Mr. Robert Lusk introduced a Resolution (#107) passed by State Law that gave the Clerk of Court and Probate Judge an additional \$1500.00. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to approve the issuance to both for salary supplements and additional monies for clerical help which has been placed in the general fund.

Mr. Lusk informed Council that Mr. Phillips from Sir Pontiac was present and had contacted him regarding three Pontiac Lemans which had been leased for the Assessor's office thru the CETA Office. These were not budgeted in the Assessor's Budget but with CETA funds. Mr. Crider stated that he has the funds available in his 1980-81 budget if CETA funds do not become available. Mr. Poore recommended that we go ahead and take the cars. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to go ahead and take the cars.

On the motion of Mr. Hooper, seconded by Mr. Wiles, Council voted unanimously to adjourn at 7:35 p.m.
