I have asked for help several times due to the fact that I am an indigent father because I have lost my jobs several times going to court being put in jail for being behind on child support. Kaleb Cash is my son with her , but I have learned that she was married to Brian Cash when Kaleb was born and in the State of SC laws Kaleb is not even considered to be my son. I learned last week I AM NOT EVEN ON HIS BIRTH CERTIFICATE. SC laws state that before any support is ordered paternity is to be legally established. I would like the help of child support office and Ms Hope Blakely to do the right thing. I need a hearing because my support order is based off of an income from 2008 which i do not make. I also have read that 2011 the federal government stopped sc spartanburg county from putting indigent parents in jail as A FEDERAL LAW THAT IS NOT BEING FOLLOWED.....I NEED HELP I am not a bad father just one who can not get ahead due to being in court everytime i turn around. Now knowing my ex was married when we had what I believed to be my son and daughter kaleb and maddison cash my children now I know her ex husband she did not divorce until a year after maddison was born who just so happens that his last name is also Cash. I would like a response by email or calling 864-308-9772 my name is MIKE CASH or I am going to governors office with this and WSPA.....You have not proven paternity and legally BRIAN CASH IS THE FATHER OF the two children in my order because they were married and technically carry his nameHOW DOESTHIS SLIP THROUGH THE CRACKS WHY DID I NOT KNOW I WAS NOT EVEN ON BIRTH CERTIFICATES AND HOW HAVE I BEEN PUT IN COUNTY OVER AND OVER WHEN SC LAWS SAY ANOTHER MAN HER HUSBAND IS LEGALLY THEIR FATHER? I HOPE TO HEAR FROM YOU BY NOON TOM OR IM GOING TO MEDIA. IM REACHING OUT ASKING FOR HELP YET AGAIN. I WAS ORDERED TO PAY HER 3,150.00 WHEN MY AREEAR WAS ONLY 1587.00 NOW I HAVE TO GO TO JAIL BC I CANT COME UP WITH MORE THAN I WAS EVEN BEHIND

She would not take that. I did not get all 3000.00 of my tax money. I can not keep a job due to in and out of jail over this. I want to do a decrease in the support order but I have to have an attorney for that also. Exactly how does an indigent parent pay for a private attorney and child support based off of 40,000.00 a year that has not been addressed since 2008. Mrs. Dill I am not a bad person and I try to do right by all of my children. Danielle uses this over my head. As control. I see the kids I give them anything they have asked me for. This is a vendetta bc she does not like my wife. I have a baby due in 8 weeks. I have came up with 1000.00 to give her can not come up with more and she says no. How do parents like myself get ahead? How am I suppose to be actively working taking care of anything when she is constantly bringing me in front of the judge and Im held accountable to pay a support order I can not afford. By sc guidelines I should only be paying her 28.72 a week my order is for 168.50 weekly. Can you direct me to helping all involved. I can not do What I can not do.

Have no legal right to either child because in sc eyes they are not mine they are brian cash children I keep asking for help but do not find any.

I am also going to send Gov Haley copies off all the emails I send to family court. I got a call back from them yesterday.

I was very surprised, but thankful. I just do not understand how in 2011 The federal Gov stops the state of SC from putting indigent parents in Jail then finding out I am not on birth certificates and she was MARRIED to another man when they were born , but I have to worry of going to Jail I have to lose work and I have to seem as if I am the bad guy. Danielle and her boyfriend Jesse just put 10,000.00 in cash on a new home. I get that she can do that with her money none of my business. I struggle I offer she refuses. Says she will do whatever is on her power to make sure I am not here for the birth of my son until Maddison in 18 she controls me. Sad part is SHE actually does.

I just want some one to see the wrong in all this. To help people like me. If this does not help my case I hope it helps other's. If I have to go all the way to the supreme court to let the state and federal goverment know there is no hel;p and the law passed in 2011 due to the jail records being so high of child support parents in there that it was to stop I will. My next email is Jean Tolison head of court of family court. Then Ill work my way to news channels. This is not right how indigent parenst are treated. HELP US HELP OUR SELF OUR KIDS GET ON OUR FEET NOT KNOCK US OFF>>>>WHO DOES IT HELP WHEN I SIT IN JAIL? MY KIDS? THE OTHER PARENT? ME FUTURE EMPLOYMENT HISTORY? NO ONE . Kourtney Dills response back to me:

Mr. Cash,

The child support order with Danielle came from a DSS protective services order. They are the ones that you would need to talk to in regards to your questions about paternity. I understand DSS child support services are not a party to that case. The only other option you have when it comes to a decrease in support other than filing through an attorney is to file it yourself. <http://www.sccourts.org/forms/indexSRLChildSupport.cfm>. This is where you would get all the forms you would need for the process. It has a form to fill out also to ask for the \$150.00 filing fee to be waived. It also has a script of what to say in the courtroom. As for the amount of money I can only accept \$3000.00 if Danielle is not willing to accept the 1000.00 and write off the rest. I'm sorry I could not be more help.
