The Federal Communications Commission's Sixth Circuit loss last week over its push to promote expanded municipal broadband by preempting state laws leaves the FCC with little recourse but to ask a likely reluctant Congress for new authority, experts said.

The General Services Administration said Wednesday that it agrees with the interpretation of agencies such as the U.S. Equal Employment Opportunity Commission that sex discrimination includes bias based on gender identity, saying that federal facilities must adhere to that rendering of anti-discrimination statutes.

#### S&P Urges Transparency In Banks' Plans To Weather A Crisis

Globally systemically-important banks need to provide more information to their creditors about their recovery and resolution plans and internal financing so that investors can better understand the risks involved during a crisis, Standard & Poor's Financial Services LLC said in a report published Wednesday.

#### IRS Finalizes Foreign Procurement Excise Tax Guidance

The IRS released final rules on Wednesday on the 2 percent excise tax on the U.S. government's payments to foreign persons for goods or services provided under a government contract.

#### FCC Pushed To Recognize Special Access Competition
