Hi Katherine,

We had met you during Governor Haley's visit to Mumbai.

We have a plant in Walterboro and last month our Managing Director had been denied entry into the US on grounds of an "invalid" visa.

I believe you are aware of our case.

With our repeated conversation with Kay Maxwell and the Congressman's office, in spite of the visa being an acceptable one, we took the best course of action and applied for a new visa as recommended by the US customs to ensure this problem does not repeat.

We filed our case and received notification of the receipt and review of the visa application from the US a week ago.

Today we heard back asking for "more evidence".

Honestly, this is turning out to be quite time prolonging and we are extremely disheartened.

As a company, we have invested in the United states and South Carolina and this requires us to visit and monitor our investment periodical. With constant hassles such as this, I am not sure how are we expected to work?
