Senator Richard Cash's **Amendment** ( **No. 67** ) defunding Planned Parenthood in **Section 33** ,  
the Department of Health and Human Services section of the 2018-2019 SC State Budget, **H.4950**  
was tabled on the second, decisive Tabling Motion by a vote of **22 Yes - 20 No** to table.

This means if any ONE of these 22 Senators below had voted "No" instead of voting "Yes" to table,  
the vote would have been 21 Y - 21 N, and the Tabling Motion would have failed:

**18 Democrats : Allen, Fanning, Hutto, Jackson, Johnson, Kimpson, Malloy, J. Matthews, M. Bright Matthews, McElveen, McLeod, Nicholson, Reese, Sabb, Scott, Setzler, Sheheen, Williams**

**4 RINO "Republicans" : Campbell, Leatherman, Massey and Rankin.**

Furthermore, THREE SENATORS who had just voted "No" against tabling in the first Tabling Motion which failed ( **16 Y - 24 N** ), then **abstained** in the second Tabling Motion **22 Y - 20 N** vote: **Cromer, Senn, Shealy.**

If these three had continued to vote "No" against tabling in the second Tabling Motion, it would have again failed, by a vote of **22 Yes - 23 No.**

There were two attempts to table (kill) the Senator Richard Cash Amendment No. 67 on April 12. The first by leading pro-"abortion" Senator Brad Hutto, Esq. failed on a 16 Y - 24 N vote. Among the 14 D's and 2 R's voting to table (the pro-"abortion" vote), were Democrats Jackson, Reese and Setzler. The two "Republicans" (RINO's) were Massey ( Senate Republican Majority "Leader" ) and Rankin ( "former" Democrat, and Chairman of Senate Judiciary Committee ).

The second tabling motion by pro-"abortion" Senator Margie Bright Matthews, Esq., was successful on a 22 Y - 20 N vote. Among the 18 D's and 4 R's voting to table were Democrats Jackson, McElveen, Reese, Setzler and Williams. The four "Republicans" (RINO's) were Campbell, Leatherman ( Senate Pres Pro Tem, and Chairman of Senate Finance Committee ), Massey and Rankin.

Planned Parenthood has committed 47,500 child-murders-by-“abortion” in Columbia, SC as reported by DHEC, 1978-2015, presently operating an “abortion” center at 2712 Middleburg Drive, Suite #107, Columbia. Nationally, affiliates of Planned Parenthood Federation of America are murdering over 300,000 children in the womb each year in the United States. Planned Parenthood's evil origins date back to 1916 when Margaret Sanger opened the first birth control clinic in the United States in Brooklyn, New York, for which she and others were arrested. “Birth control” (child prevention), a term coined by Sanger in 1914, was illegal. Margaret Sanger formed the American Birth Control League in 1921, which later combined with other organizations, became known as the Planned Parenthood Federation of America in 1942, as the horrors of the eugenic policies of Adolf Hitler's Nazi Third Reich became increasingly known.

Margaret Sanger believed in eugenics , and advocated birth control as a means of achieving her radical, racist, and sexually immoral goals. Sanger herself was an unapologetic, decades-long adulteress, even forcing her third and last husband, wealthy businessman Noah Slee, to sign a written agreement before the marriage , to insure her independence from him, including continuance of her profligate, lascivious, sexual immorality with other men.
