**Graduations, Georgia CWP Reciprocity, Military Retirement, and Much More – Update from May 31 to June 6, 2016**

Good afternoon! One of my goals as your state senator is that you find this legislative update informative, and I appreciate any feedback. If I can help you with an issue, please let me know. We have been very busy in recent weeks assisting many constituents with a variety of issues. Thank you for allowing me to serve our District!

**State Government News**

**Georgia CWP Reciprocity -- Enacted:** The Governor signed this bill last Friday after it received final passage in the Senate on Wednesday night. Sponsored by Rep. Bill Hixon of North Augusta and co-sponsored by other members of the Aiken County legislative delegation, the legislation requires South Carolina to recognize Georgia concealed carry permitholders. Because South Carolina passed the legislation to recognize Georgia and the Governor signed it, there is now reciprocity between the two states because Georgia law already says Georgia will recognize permits for residents of any state that also recognizes Georgia. Like other states with whom our state has concealed carry reciprocity, Georgia concealed carry permitholders must abide by South Carolina concealed carry laws while in South Carolina.

**Military Retirement Pension and State Income Tax:** On Thursday, the General Assembly gave final approval to this legislation which will phase in over the next five years. At the end

of the five years, military retirement pensions of up to \$30,000 annually will be exempt from state income tax for someone 65 and older. Military pensions for those under age 65 will be exempt up to \$17,500.00. Current law allows an exemption of up to \$15,000 for those 65 and older. The bill is also important to the state's Military Base Task Force which is working now to position our state as strong as it can be when the next Base Realignment Commission convenes on the federal level.

**Roads:** Last Tuesday night, the Senate adopted an amendment to the roads legislation changing how highway commissioners will be selected. Currently, there is one highway commissioner for each Congressional district on the SCDOT Commission with one at large appointment. All commissioners except one on the SCDOT Commission are selected by the respective congressional district legislative delegation. The Governor has the at large appointment. The Senate amendment last Tuesday night allows the Governor to nominate a highway commissioner but the legislative delegation from the congressional district for the highway commission slot (the commissioners are by congressional district) has to approve of the nomination. If the congressional district legislative delegation does nothing, then the nomination fails after 45 days. I voted against because I did not view this change as giving the Governor more control over the selection of the SCDOT Commission which is one important aspect of necessary SCDOT reform about which I have heard from constituents for quite some time. This also was a departure from what the Senate approved 30-15 in early March whereby the Governor would appoint all members of the SCDOT Commission with confirmation by the Senate. On Wednesday, the House adopted the Senate's newly amended version and the bill now is up for the Governor's consideration. As of the time of this email, the Governor has not signed it. There are other aspects to the bill that are good including a large roads funding component without a gas tax increase. **Ethics -- Income Source Disclosure and Independent Investigations:** There are two ethics reform bills that are in a legislative Conference Committee. The ethics income source disclosure requirement appears to be in good shape to be enacted this year. However, there is a disagreement on a portion of the independent investigation part between some senators and the House of Representatives version. The disagreement is over the "probable cause" determination AFTER an investigation by the State Ethics Commission. The Senate version provides that the final determination of probable cause lies with the legislative ethics committees. The House version provides that the State Ethics Commission makes the final probable cause determination. I will support the House of Representatives version if that is presented to the Senate out of the Ethics legislation Conference Committee.

**Eminent Domain -- Palmetto Pipeline:** Last week, the House passed the bill and the Governor signed it into law on Friday. This bill clarifies that state law does not allow a private, for profit, unregulated company to take land by eminent domain. The bill includes a moratorium for up to 3 years while a Committee reviews under what circumstances, if any, petroleum pipeline companies are allowed to use eminent domain in other states. In March, Kinder Morgan announced that it suspended further work on the proposed Palmetto Pipeline project between Belton, S.C. and Jacksonville, Florida including portions of Aiken and Edgefield counties. In its announcement, Kinder Morgan cited significant legislative opposition in Georgia. Similar to South Carolina, Georgia enacted a moratorium and has commissioned a study committee to review its current laws in this area.

**Restructuring -- Shortened Legislative Session:** Last week, the General Assembly passed legislation (S.267) that I sponsored to shorten the legislative session. Currently, the General Assembly meets three days per week from the second Tuesday in January to the first Thursday in June. The legislation requires the regular legislative session to end on the second Thursday in May which shortens the session by 3 or 4 weeks depending on how the second Thursday in May falls in relation to the first Thursday in June. The Governor signed the bill on Friday.

**Roll Back Taxes:** The Governor signed this bill last week too which includes an amendment that Senator Campsen and I offered to change state law to allow a new owner to appeal a rollback tax bill and prevail if the rollback tax was issued solely because a new owner fails to make written application for an agricultural assessment and the use of the property remains agricultural. In the past, I heard from constituents who inherited agricultural property but they did not know to file for the agricultural exemption on the property. After finding out late, they owed the County five (5) years of back property taxes even though the use of the property had not changed. I viewed this as unfair but state law apparently did not provide a remedy. With this change, there is now a fix.

**Ice Storm Reimbursement:** After the ice storm in February 2014, local governments in 22 counties including Aiken along with the S.C. Department of Transportation incurred expenses in cleaning up public roadways. Pursuant to an emergency assistance agreement, the federal government reimbursed the counties and municipalities about 80% of their expenses. The unreimbursed portion is called the "non-federal state/local share." Last year, the General Assembly appropriated \$4.1 Million as the state's allocation share to reimburse the local governments in the 22 counties for about 25% of their non-federal reimbursed expenses. This year, an appropriation to reimburse the remaining 75% of the non-federal reimbursed expenses failed to survive in the Budget Conference Committee. I am optimistic that the money will be appropriated in 2017. If so, Aiken County will receive the largest portion of these funds with other local governments including the City of Aiken, City of North Augusta, and Town of Jackson also receiving funds.

**Budget Conference Report -- Other Local Items:** In spite of the ice storm reimbursement not surviving in the Conference Committee, other significant parts of the budget to mention for Aiken County are as follows:

- USC Aiken - \$400,000 increase in recurring dollars (+5.5%)
- Aiken Tech - \$784,216 in training equipment
- Aiken Tech - \$7 million for the Life Science Building
- \$126,000 in additional Parks & Recreation funding
- \$1.795 million in additional funds for road repaving directed to the County Transportation Committee
- \$305,500 additional from the non-recurring Local Government Fund

**Budget to Governor:** Governor Haley now has the budget and any vetoes that she issues will be considered by the House and the Senate on June 15 and June 16.

**Patent Trolling:** "Patent trolling" is the process of filing a claim of patent infringement against an entity, despite the fact that the claimant does not manufacture or supply the product or service in question. Patent trolls often file claims in bad faith, hoping that the company being sued decides to settle in order to avoid expensive litigation costs. While patent law is

traditionally a federal issue, in May 2013, Vermont became the first state to pass legislation to attempt to halt patent trolling. For the past three years, legislation has moved through the General Assembly and received final passage last week where South Carolina will join Vermont and nearly 20 other states passing similar anti-patent trolling legislation.

**FOIA Bill:** The FOIA provision is now in a Conference Committee with the law enforcement dashcam video bill. They are on the same legislation. The Senate passed the dash cam bill and the House amended the bill to address the FOIA provision. As reported in Sunday's *Aiken Standard*, the Conference Committee is at a stalemate on whether to include the FOIA provision with the dashcam language as part of the Conference report to the Senate and the House. I support the FOIA bill and encourage the Senate conferees to do so. A lot of local residents are interested in the FOIA bill. We should know more by June 16.

**S.C. State University -- Loan Relief:** In the past 24 months, S.C. State has received loans of over \$18 Million from the State to help the school address its budget deficits. Last year, the General Assembly terminated the entire Board of Trustees and approved a new Board. With the new leadership, S.C. State has made improvements and kept its university accreditation. Last week, the Senate passed legislation that would forgive \$12 Million in loans that were made to the school. I voted against the bill.

**Moped Law Enacted:** Last week, the House and the Senate approved legislation requiring moped drivers to be licensed and making it unlawful for a person operating a moped to drive while under the influence of alcohol.

**Japanese Plutonium:** Today's paper reports that Japanese plutonium has arrived at SRS. Representatives from the National Nuclear Safety Administration (NNSA) appeared at the April 2016 Governor's Nuclear Advisory Council Meeting. The NNSA representatives provided an update within security limitations on the Japanese plutonium. They said there are 331 kg (about 1/3 of a metric ton) of plutonium coming to SRS to be downblended and then shipped to New Mexico for long term storage. That plutonium is a portion of the six (6) metric tons that the Department of Energy (DOE) has confirmed will be downblended and removed from SRS.

**SC Help -- Primary Residence Foreclosure Avoidance Assistance:** Several Aiken County residents have received assistance under a federal program instituted in 2011 in several states including South Carolina providing one time assistance to homeowners who risk foreclosure. The program loans up to \$36,000 in one time aid to homeowners who have fallen behind on mortgage payments for a variety of reasons. Acceptable causes include: unemployment, underemployment, a sharp reduction in self-employment income, a divorce, death of a spouse, unexpected medical bills from a catastrophic illness or injury, or damages stemming from the October 2015 floods. The home involved must be the applicant's primary residence and there is a cap on the size of the original mortgage loan amount.
