Thank you for your letter regarding South Carolina Medicaid providing access to the drug, Makena®. We welcome the opportunity to be of assistance.

The South Carolina Department of Health and Human Services (SCDHHS) currently covers both 17 alpha hydroxyprogesterone caproate (17-P) and Makena® which have the same clinical indications. A bulletin was issued on May 18, 2011 outlining the policy and procedures for both products. For your convenience we have included the link, <http://www.scdhhs.gov/Internet/pdf/17AlphaHydroxyprogesteroneCaproate.pdf>. This bulletin implemented a prior authorization process for the Makena® product which requires clinical justification and documentation of medical necessity.
