Dear Sheriff Loftis, Major, and Detective Sargent, Greenville County, Sheriff's Office,

Mr. Gerard Watkins was arrested last week along with one of our teen gangs, few members. Investigators discovered 100 lbs of drug weed. One drop in an Olympic size pool. This drug dealer, den of iniquity, was a target at large for some time to break in. He was not liked, abusive to women, especially hooked on drugs. Just a punk drug dealers, always on forever in competition with his younger brother, Danta, Gorgio, Elgin Watkins, drug lord.

In brief, and please take the time to read, thank you. Gorgio and Elgin Watkins both raised by Red Erby Jennings (deceased) at 6 and 10 Addie Court. Their mother (alive) persuaded Red Erby they were his sons. Street talk at large is reliable, dependable, and most times credible, said otherwise. Both of these males had two different fathers.

Red Erby, known to many, was more than a drug lord, among the long time drug lord families in the Sullivan, Sterling, and surrounding communities, of Greenville, SC and beyond. Mr. Erby raised both males at 6 and 10 Addie Court next door to 8 Addie Court. He also helped raise the niece. Her and her aunt's employment was and still is correctional employees. Red Erby had connections with city police. City police was informed.

They were also informed the three properties 6, 8, 10 Addie Court were connected, which was the subject of approximately 2000 days of my investigation. What a setback and terrible blow that no investigations took place, no police interest, provided no police contact. 6, 8, 10 Addie Court was more than 2000 days of investigations. Drugs were manufactured at 6 Addie court, stored, transported, distributed, locally and delivered and sold from 6 and 10 Addie Court. Between them and in the middle lived, worshiped, and went to business at the correctional institution, the aunt and niece at Addie Court.

There was a fire at 10 Addie Court, this time terrible odors. Fire trucks came put the fire out, there was no examination or investigation of the debris. Calls were also placed to the health department. There were numerous cars at 10 Addie Court for a long time before the city inspectors addressed that issue. The cars were used to store drugs, drug hangovers, most by and used by customers of drugs.

The city police was provided information on going. So close to catch one key delivery driver via scooter, the same scooter and man on record for years. No investigation ever took place. Suddenly they were alerted. Elgin and family moved out, 6 Addie Court became a trap house to store and sell drugs. I did not handle the loss of such a long time wasted investigation well. The results, I had a stroke recently. I am back now with more chapters.
