The Technology Grant Review Committee will review applications and select the iPad award recipients. All applicants selected to receive an iPad 4 will be contacted on December 9. If selected, the iPad will be shipped via UPS directly to the address provided with the application. Others will receive an email informing them of their status.

**Note:** Only applicants in the United States will be considered. We cannot accept applications from outside the United States.
