
Please be advised that I have been retained to represent Robin M. Egarter as Personal Representative of the Estate of Elizabeth M. Egarter.

Dear Mr. Connell:

This agency, the Department of Health and Human Services, administers the South Carolina Medicaid Program and several other federal grants. The South Carolina Department of Health and Environmental Control (DHEC) is the state licensing agency and the state survey agency for facilities participating in the Medicaid and other programs. This agency receives reports from DHEC when the facility's compliance is in jeopardy, so that this agency can take appropriate steps with respect to participation in the Medicaid Program. After a check of the file in the relevant unit of the agency, we do not have any documents that are responsive to your request for the time period in question. Obviously, the primary source for all survey and complaint follow-up would be DHEC.

The State Long Term Care Ombudsman (SLTCO) investigates complaints made to her office regarding abuse, neglect, or exploitation of vulnerable adults occurring in facilities. If necessary and appropriate, this agency would receive a report of the Ombudsman's findings. However, we have no documents responsive to your request. The primary source for such complaints and investigations would, of course, be the Ombudsman's Office, which is located in the Lt. Governor's Office.
