Jane Page Thompson sent me this message – she and Karen Poteat who is a long term care administrator in Aiken would like to meet with the Lt. Governor or his designee on this issue -- pls contact his office to see how they should set up meeting:

Need an appointment with Lt. Gov and DHEC about SC's void in Senior care classifications for the Aging. (Long story As short as possible) There is Tsunami of Dementia and Alzheimer's coming and SC is not ready because we lack a variety of classification for Seniors. For example: a senior center is not under DHEC but a for-profit organization that should not be under the control and regulation of DHEC yet is because there is no classification- meaning everyone is forced into the DHEC regulations even if they don't apply to their business. But there are some financial benefits to families to have a DHEC facility but the category for Adult Day Care in SC needs to be expanded to address the various phases of Adult day care right now it's one size fits all when we need to be more flexible than that because new research shows that there are phases. I understand this is a complex topic however the governor in his pursuit to reduce regulatory burden on small business would be excited to see this broadening category be allowed to be licensed in the state rather than not having these businesses license because of the regulatory hurdles it takes to get them operational
