### Gov. Nikki Haley stumps for Sen. Rubio in Atlanta:

Marco Rubio's voice was hoarse. Nikki Haley's was not. So it was the 44-year-old South Carolina governor, not the 44-year-old Florida senator, who gave most of the remarks at a rally here Monday afternoon, taking Rubio's latest caustic riffs about Donald Trump and making them her own.

**Note:** "I have to tell you, Donald Trump is everything I taught my children not to do in kindergarten," Haley said, standing alongside Rubio. Haley added that she also taught her two young children to defend themselves: "When a bully hits you, you hit that bully right back!"

**Note:** Haley's fiery speech on the eve of the Super Tuesday contests captured Rubio's candidacy at the moment: increasingly personal in its attacks on Trump and quickly becoming the main vessel for mainstream Republicans but far from a sure bet for the nomination.

**Note:** "Now let's get serious," Haley implored, ticking through a list of Trump's past business projects that have drawn controversy.

**Note:** "We've seen it with Trump Vodka, we've seen it with Trump mortgage, we've seen it with all of his Trump endeavors. And right now he's being sued for fraud with Trump University. Every single one of them has failed," Haley said. "Now he wants to run for president. This is not a game. We are not a project."

Gov. Nikki Haley of South Carolina, campaigning here on Monday with Senator Marco Rubio, joined the growing number of outraged Republicans who are condemning Donald J. Trump for not speaking out against white supremacy more forcefully.

**Note:** "The K.K.K. came to South Carolina from out of state to protest on our Statehouse grounds," she told a ballroom of more than 1,500 Rubio supporters at a hotel in the Buckhead section of Atlanta on Monday, eliciting boos as she mentioned the Klan. "We saw and looked at true hate in the eyes last year in Charleston," she added. "I will not stop until we fight a man that chooses not to disavow the K.K.K. That is not a part of our party. That is not who we are."

Nikki Haley is now tag teaming with Marco Rubio in going after Donald Trump. At a rally in Atlanta, Georgia the day before Super Tuesday, Haley slammed the real estate mogul's failed business ventures and the fact that he didn't disavow the Ku Klux Klan during a CNN interview over the weekend.

**Note:** "Donald Trump is one who goes after project after project after project," Haley said, before listing multiple ventures that were no longer successful. "Every single one of them has failed and now he wants to run for president? This is not a game. We're not a project."

**Note:** "We saw and looked at true hate in the eyes last year in Charleston. I will not stop until we fight a man that chooses not to disavow the KKK. That is not a part of our party. That is not who we want as president."

**Note:** The governor said that she was an accountant and there was nothing that precludes Trump from sharing his returns while being audited. "Donald Trump show us your tax returns," she said forcefully.

**Note:** When Rubio took the stage, he praised Haley. "If you ever need to be pumped up...you call Nikki Haley and she'll get you going, it'll be unreal," the Florida senator said. "That is what our party is about."

As Donald Trump moves closer to sewing up the nomination, Republican lawmakers are publicly deciding whether to back Trump—or back away from him. He has nailed some of his first major endorsements in recent days by elected officials, but just as many others have thrown their weight behind other candidates and aim to take him down as the crucial Super Tuesday primaries loom.

**Nikki Haley:** The South Carolina Governor has thrown her weight behind Rubio and has pivoted to attacking Trump in recent days along with him. "Donald Trump is everything we teach our kids not to do in kindergarten," Haley said recently, according to The Post and Courier. "We have seen behavior over and over again that is just unacceptable... I think what we saw from Marco is what we tell our children also: If a bully hits you, you hit back." This shows that since Rubio's performance in the most recent Republican debate when he came out swinging at Trump, other politicians who back him (South Carolina Rep. Trey Gowdy and Sen. Tim Scott, for example) may become more vocal in their opposition to Trump, as well.

From the market's perspective, it's nearly all over. All the smart money is now on Trump. Before the Nevada caucuses, Trump had hardened to about 53 percent for the nomination—the highest he's been since January. Suddenly he surged past 70 percent, a new record—and he kept going.

**Thank Nikki Haley for Cruz's free-fall**

The moment of the Nikki Haley endorsement was a turning point for Ted Cruz. Almost from the moment of her speech, Rubio's and Cruz's number start to move—Rubio went from a 26 percent chance to win the nomination to 42 percent, and for the presidency, 12 percent up to 18 percent.

**The good news: Jeb finally kicks the can**

Again, it comes back to Haley. The Haley endorsement was an absolute death knell for Jeb Bush. Before the endorsement, Bush was about 11 percent for the nomination; within hours of the Haley announcement, he was down to 4 percent, then 3 percent, for the nomination—maybe even less. He was just collapsing.

South Carolina and two counties hardest hit by last fall's catastrophic flooding will share \$157 million from the federal government. U.S. Department of Housing and Urban Development Secretary Julian Castro announced the disaster recovery awards Monday. The state will receive nearly \$97 million. Richland County will receive \$23.5 million.
