I am writing you in regards to the enclosed matter for one. I am also writing in regards to the Evans Correctional Institution which I am writing from and their Civil, Human and Constitutional violations that are metted out daily. Right now the Dorm I live in has had their outside toilet facility closed for over 4 months now. The institution's Associate Warden, Sellers and Major West cite the reason is Security. Although the doors to the cells are locked and most persons in this Dorm have numerous medical issues, they refuse to reopen the outside toilet. There is no other Dorm presently without an outside toilet. The Inmate's are forced to use the toilet in the Showers. This is unsanitary and Evans Administration has been notified of this abuse by it's administration. This is only one infraction. We have health, medical, abuse of force, abuse of the Disciplinary System, questionable monetary issues etc. Please take note of this letter and initiate an investigation.
