

The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:


That on October 28, 2015, the above named defendant, Robert Paul Suchey, did commit the offense of violation section 16-15-395 of the South Carolina Code of Laws, 1976 as amended, First Degree Sexual Exploitation Of A Minor (Attempted), in that he did willfully, unlawfully, and knowingly coerce and encourage what he believed to be a 14 year old minor, while that minor was in Charleston County, South Carolina, to appear in a state of sexually explicit nudity, as defined by Section 16-15-375 of the South Carolina Code of Laws, 1976 as amended, and take a photograph herself for the purpose of producing material that contains a visual representation depicting the minor in a state of sexually explicit nudity for the purposes of sexual stimulation.


On 10/28/2015 Detective J. Bowen, of the Charleston County Sheriff's Office, in the discharge of his official duties as a member of the South Carolina Internet Crimes Against Children Task Force, was conducting a proactive, undercover operation in which he was posing as a 14 year old female online. During this operation the suspect, later identified as Robert Paul Suchey, engaged in a conversation via text message and email with Detective Bowen's 14 year old persona. During this conversation Suchey asked, via email, the child persona to send him a photo of her nude vagina. This requested was preceded, and followed, by very sexually explicit messages from Suchey to the child persona portrayed by Detective Bowen. At several points in the communication, prior to requesting a nude photo, Suchey references the persona's age as 14, indicating his belief that he was communicating with a 14 year old.

This information is known through the investigation of Detective J. Bowen of the Charleston County Sheriff's Office, and of the South Carolina ICAC task force, and he is witness to prove the same against the form of the statute in such case made and provided against the peace and dignity of the State.

On 10/28/2015 Suchey began detailing numerous and varied sexual acts he would like to perform on the 14 year old persona. Suchey also asked the child persona what type of sexual acts she would like to participate in. On several instances during the communication, Suchey references the persona's age as 14, indicating his belief that he was communicating with a 14 year old.



The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on October 28, 2015, the above named defendant, **Robert Paul Suchey**, did commit the offense of violation section 16-15-345 of the South Carolina Code of Laws, 1976 as amended, **Dissemination of Obscene Material to a Person Under the Age of 18 (Attempted)**, in that he did willfully, unlawfully, and knowingly disseminate to a person whom he believed to be under the age of eighteen, while that person was in Charleston County, South Carolina, material which he knows to be obscene within the meaning of Section 16-15-305 of the South Carolina Code of Laws, 1976 as amended, while he was 50 years old.


On 10/28/2015 Detective J. Bowen, of the Charleston County Sheriff's Office, in the discharge of his official duties as a member of the South Carolina Internet Crimes Against Children Task Force, was conducting a proactive, undercover operation in which he was posing as a 14 year old female online. During this operation the suspect, later identified as Robert Paul Suchey, engaged in a conversation via text message and email with Detective Bowen's 14 year old persona. During this conversation Suchey sent a video showing the torso of a nude adult male with an exposed erect penis being touched by the subject in the video. This video was preceded, and followed, by very sexually explicit messages from Suchey to the child persona portrayed by Detective Bowen. At several points in the communication, prior to sending the video, Suchey references the persona's age as 14, indicating his belief that he was communicating with a 14 year old.

This information is known through the investigation of Detective J. Bowen of the Charleston County Sheriff's Office, and of the South Carolina Internet Crimes Against Children task force, and he is witness to prove the same against the form of the statute in such case made and provided against the peace and dignity of the State.

The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:


That on November 19, 2015, the above named defendant, **Robert Paul Suchey**, while at 1 Windsor Dr., Charleston, in the County and State aforesaid, did commit the offense of violation section 16-3-655(B)(1) of the South Carolina Code of Laws, 1976 as amended, **Criminal Sexual Conduct with a Minor, 2nd Degree (ATTEMPTED)**, in that he did willfully, unlawfully, and knowingly attempt to engage in sexual battery with a person whom he believed to be 14 years of age while he was 50 years old.

On 10/28/2015 Detective J. Bowen, of the Charleston County Sheriff's Office, in the discharge of his official duties as a member of the South Carolina Internet Crimes Against Children Task Force, was conducting a proactive, undercover operation in which he was posing as a 14 year old female online. During this operation the suspect, later identified as Robert Paul Suchey, engaged in a conversation via text message and email with Detective Bowen's 14 year old persona. During this conversation on 10/28/2015 Suchey stated he would like to meet the child persona in person and take her to a hotel. Suchey then detailed the sexual acts he would like to commit upon the child persona. During subsequent conversations Suchey continued to request to meet the child persona, all while detailing the varied and numerous sexual acts he would like to perform upon her. Detective Bowen, as the child persona, agreed to a meeting on 11/19/2015 at 15:00 hours with Suchey. The meeting was arranged to occur at 1 Windsor Dr., Charleston, SC. On 11/19/2015 at 14:22 hours a controlled call, by a female Sheriff's Office supervisor, was initiated to Suchey, after several requests from him. Suchey confirmed in that call that he was in route to meet with what he believed to be a 14 year old female. In the call he firmly indicated he knew her age to be 14, and again detailed sexual acts he intended on committing upon the 14 year old persona. At approximately 15:00 hours Suchey arrived at the agreed upon location and was taken into custody.


