New Grantees Announced to Expand Oral Health Access for Pregnant Women and Infants

The Maternal and Child Health Bureau has announced eight new states will receive grants totaling nearly \$2 million to implement projects to improve access to oral health care for pregnant women and infants. The new grantees join Connecticut, New York and West Virginia in the Perinatal and Infant Oral Health Quality Improvement (PIOHQI) program. These 11 states join a network of national organizations including NASHP, the Children's Dental Health Project, the Association of Maternal and Child Health Programs, and the Association of State and Territorial Dental Directors to improve systems of care to pregnant women following the goals of the PIOHQI initiative.
