I have to say that I am quite impressed with how this is coming together. The inclusions that everyone sent yesterday have made a huge difference. Attached to this email you will find a full 35 (actually 36) page version of the narrative for your review and comment.

I would ask that you pay particular attention to the OAH scoring rubric when you read this document to ensure that we have covered all points. That can be found on pp. 35-41 of the RFP.

Contrary to something that I said yesterday I would much prefer your comments in written form (old school writing on a printed copy)!!! Given the spacing, inclusion of charts, etc, etc I think that track changes could get a little messy. Sue/Amy, I have to leave the office today by 3:30. - 3) Doug and I will be working on the work plan today. It is blank right now, but I inserted a full two pages so we have plenty of room to fill in activities, timeline, etc.

That's it for now. I will be sending the logic model and other documents for review later today.
