## **AIRS Annual Information & Referral Conference Call for Proposals**

The Alliance of Information and Referral Systems (AIRS) has released the call for proposals for the 2016 Annual Information and Referral (I&R) Training and Education Conference. AIRS is seeking workshops addressing the breadth of I&R service delivery. The Aging and Disability track provides a valuable opportunity to share developments and effective practices in serving older adults and persons with disabilities with I&R colleagues across the country. This track is coordinated by NASUAD's I&R Support Center, which strongly encourages aging and disability I&R agencies to review the call for proposals and consider a submission. Topics such as family caregiving, elder justice, mental health, aging with a disability, developments in home and community-based services, cross-sector partnerships and collaboration (including ADRC and 2-1-1 partnerships), No Wrong Door system building, ADRC funding and sustainability, use of technology in I&R, transportation, health coverage (Medicare and Medicaid coverage), and data collection and quality assurance are all topics of interest in aging and disability I&R.

## **Funding Sources Available to States to Help Low-Income Persons**

The Robert Wood Johnson Foundation (RWJF) and National Academy for State Health Policy (NASHP) created a resource that explains the funding sources available to states for meeting the health-related social needs of low-income persons. NASHP and RWJF created this resource because the Center for Medicare & Medicaid Innovation (CCMI) created the Accountable Health Communities initiative that is meant to bridge the gap between health care and social services. The publication specifically brings attention to funding sources that states can use to help adult high-cost/high-need residents live.

## **Additional Oversight Needed of CMS' Demonstration to Coordinate Care**

The Centers for Medicare & Medicaid Services (CMS) began the Financial Alignment Demonstration in 2013 to improve care coordination. GAO was asked to examine care coordination under this demonstration. On January 19, The Government Accountability Office publicly released a report with their recommendations for CMS. GAO found that the states have a fair amount of flexibility in designing their demonstrations which resulted in different measures in each state. GAO recommends that CMS develop new measures and align the current measures to improve oversight of care coordination.

### **Centers for Medicare & Medicaid Services**

#### **Final Rule to Improve Medicaid Prescription Drug Rebates/Reimbursements**

On Thursday, January 21, 2016, the Centers for Medicare & Medicaid Services (CMS) finalized a rule that explains reforms to the rebate and reimbursement systems for Medicaid prescription drugs. This rule should save the federal and state governments \$2.7 billion over a five year span. Included in the rule are new definitions, long-term framework for implementation of the Medicaid drug rebate and reimbursement programs, and details of how the rebates are calculated. Prescription drug prices are at an all time high, this rule is one step the federal government is taking in an effort to lower costs. CMS is still considering comments on the final rule at this time.

#### **Physician-Focused Payment Model Technical Advisory Committee Meeting**

The United States Department of Health and Human Services (HHS) announced the first meeting for the Physician-Focused Payment Model Technical Advisory Committee. The Medicare Access and CHIP Reauthorization Act of 2015 (MACRA) required the creation of the Committee, whose members were appointed by the Comptroller General. The Committee is responsible for reviewing proposals for physician-focused payment models

submitted by stakeholders. The first meeting of the Committee will take place on **Monday, February 1, 2016**.

## Funding Opportunities

### **Supportive Services Demonstration for Elderly Households in HUD-Assisted Multifamily Housing**

The U.S. Department of Housing and Urban Development (HUD) announced it is making approximately \$15 million available to test a promising housing and services model for low-income seniors to age in their own homes and delay or avoid the need for nursing home care.

HUD's Supportive Services Demonstration for Elderly Households in HUD-Assisted Multifamily Housing will offer three-year grants to eligible owners of HUD-assisted senior housing developments to cover the cost of a full-time Enhanced Service Coordinator and a part-time Wellness Nurse. The purpose of the Demonstration is to test the effectiveness of this enhanced supportive services model for elderly households and to evaluate the value of enhanced service coordination paired with affordable housing for seniors. The demonstration will be independently evaluated to determine the impact of the enhanced supportive services model on: Aging in place in HUD-assisted senior developments; avoiding early transitions to institutional care, and; preventing unnecessary and often costly health care events-such as some emergency room visits and hospitalizations-for residents in HUD-assisted senior developments. Grant applications must be submitted electronically by **Monday, April 18, 2016, at 11:59 p.m. ET.**

## Inclusive Planning Impact Grant

The Transit Planning for All project has announced the availability of funding for community-based demonstration programs. The purpose of this funding opportunity is to encourage development of an inclusive coordinated transportation system in which people with disabilities and older adults actively participate in both advisory and decision-making capacities. While the intention is first and foremost the development of inclusionary processes and plans, the secondary expectation is that inclusion will result in identifiable and measurable changes in the transportation system that respond to the needs and preferences of older adults and people with disabilities.

## CMS Accountable Health Communities Grant

The U.S. Department of Health and Human Services, Centers for Medicare & Medicaid Services, and the Center for Medicare & Medicaid Innovation released a request for proposal (RFP) for an Affordable Care Act (ACA) funding opportunity for Accountable Health Communities (AHC), funding opportunity number CMS-1P1-17-001. The AHC model will test three community-focused interventions of varying intensity and their ability to impact total health care costs and inpatient and outpatient health care utilization. There are different tracks-Increase Awareness, Provide Assistance, and Align Partners-with varying funding amounts available. Each track will run for a five year period. A letter of intent to apply is required and due by Monday, February 8, 2016. An electronic cooperative agreement application is due by **1:00 p.m. ET on Thursday, March 31, 2016**.

## State Health Insurance Assistance Program (SHIP) Base Grant

The Administration for Community Living released the application for the the 2016 State Health Insurance Assistance Program (SHIP) Base Grant Funding Opportunity. Congress created the SHIP in 1990 with the goal of assisting Medicare-eligible individuals, their families, and their caregivers to make informed health insurance choices. There are currently 54 active SHIP grants; one in every state, the District of Columbia, Puerto Rico, Guam, and the U.S. Virgin Islands. The funds awarded through this application are for the FY 2016 budget period, April



1, 2016 - March 31, 2017. Eligible applicants are states and United States territories that demonstrate their ability to provide the program through the state office of insurance, the state Medicaid office, or the department on aging. All applications must be submitted by **Monday, February 15, 2016, at 11:59 p.m. ET.**

## Enhanced Training & Services to End Abuse in Later Life Program Grant

The Office on Violence Against Women (OVW) has released the Fiscal Year 2016 Enhanced Training and Services to End Abuse in Later Life Program solicitation. The program provides three year awards for up to a total of \$400,000 to local communities to address abuse in later life, including domestic violence, dating violence, sexual assault, stalking, exploitation, and neglect against victims who are 50 years of age or older. Award funds must be used to organize training and cross-training for criminal justice and other professionals, develop services for older victims, and create or enhance a coordinated community response. All applications must be submitted by **Thursday, February 11, 2016, at 11:59 p.m. ET.**
