Dear Director Forkner,

I am writing to encourage you to intervene on behalf of Dr. Steven Brooks, Pediatric Ophthalmologist, from Augusta, GA.

Dr. Brooks is a fellowship trained pediatric ophthalmologist. The majority of his patients are children. However, as an eye muscle specialist, he also treats adults.

My foster to adopt son, Quentin Rotan, had a severe case of strabismus (crossed eyes). Dr. Brooks' surgery restored his vision and changed his appearance dramatically. Dr. Brooks was recommended so highly to us by another Aiken family, the Kurt Eberl family, that we felt so confident taking our little boy to him. The recommendation was not too high --- Dr. Brooks is an extraordinarily skilled physician.

It has come to my attention that SC Medicaid is disqualifying Dr. Brooks' and/or changing his reimbursement status because he does not turn away adults who need eye muscle surgery.

This is not wise. Dr. Brooks' should not be treated this way. We need Dr. Brooks' skill to help those of use with children who have severe eye problems.

Please intervene in this decision to help keep Dr. Brooks' services available to South Carolina's precious children.



Dear Ms. Willoner:

Thank you for your letter of support for Dr. Steven Brooks. We are glad that he has developed such a positive working relationship with his patients and we appreciate his dedication to them.

The reason Dr. Brooks is no longer reimbursed at the Pediatric Physicians Sub-specialist Program rate is that he no longer meets the caseload requirements for participation. In order to be reimbursed at the higher rate associated with that program, at least 85% of the physician's practice must be children 18 years or younger. This requirement applies to every provider who is enrolled in the program. Dr. Brooks is still a South Carolina Medicaid provider and can be reimbursed at our current physicians' fee schedule. In the event that his practice composition changes and he again meets the requirements for participation in the Pediatric Physicians Sub-specialist Program, he is welcome to reapply. We appreciate your support of Dr. Brooks and hope this letter has addressed your concerns.
