The Elder Law Committee (ELC) is looking at ways to improve the process for the appointment of guardians and conservators in the South Carolina Probate Courts. In cooperation with the South Carolina Association of Probate Judges Article 5 Committee, the ELC has established these goals to be addressed through proposed legislation to improve upon current law. The ELC is seeking comment on these goals and on potential ways to meet those goals from stakeholders and the public.

Supreme Court upholds nationwide health care law subsidies

The 6-3 court ruling on Thursday essentially preserves health insurance for 6.4 million Americans who receive federal subsidies and live in the so-called "HealthCare.gov states." In South Carolina, more than 90 percent of Affordable Care Act customers receive subsidies to reduce the amount they pay for insurance each month.
