SECTION 11: On motion of Commissioner Mack, duly seconded, the Commission passed a motion expressing interest in being part of the Palmetto Trails Coalition. Director Jones will research with staff and make formal recommendation to the Commission at the December meeting. Chairman Limehouse abstained from voting on this motion.

SECTION 12: On motion of Commissioner Whitehead, seconded by Commissioner Mack, the Commission unanimously passed a motion to form a partnership with Beaufort County officials to accelerate a 4.4 mile stretch of road 170 from McGarvey's Corner to the Beaufort-Jasper Education Center. Beaufort County will advance the funds and the SCDOT will form a committee to review innovative ways of accelerating this project. The SCDOT will repay Beaufort County according to the original completion schedule.

SECTION 13: On motion of Commissioner Whitehead, seconded by Commissioner Loftus, the Commission unanimously passed a motion adopting the following resolution regarding the Cross Island Connector:

#### **RESOLUTION**

**WHEREAS**, the Department of Transportation is committed to the completion of the Hilton Head Cross Island Connector with funding for the project from bond proceeds, and;

**WHEREAS**, after consideration, it has been determined to be in the best interest of the state to issue highway bonds as opposed to turnpike bonds due to financial costs and interest rate differential associated with turnpike bonds;

**NOW, THEREFORE, BE IT RESOLVED**, that the South Carolina Department of Transportation Commission requests current approval to issue up to \$60 million in general obligation highway bonds to fund the completion of the Hilton Head Cross Island Connector. These bonds will be issued in stages over a three year period as funds are required for contract payouts. The bonds will be repaid from tolls collected by a state turnpike authority which will operate the facility.

SECTION 15: On motion of Commissioner Mack, seconded by Commissioner Loftus, the Commission unanimously passed a motion adopting the following resolution:

#### RESOLUTION

**WHEREAS**, the York County Transportation Committee has voted to allocate up to \$70,000.00 of their "C" funds per year to provide for debt service on a bond issue of \$500,000.00 dedicated for the purpose of constructing a proposed road to serve an industry in the town of Fort Mill and;

**WHEREAS**, the York County Transportation Committee has requested the South Carolina Department of Transportation to issue \$500,000.00 in General Obligation "C" Fund Highway Bonds on their behalf, under Section 12-27-400 of the 1976 South Carolina Code of Laws as amended;

**NOW, THEREFORE, BE IT RESOLVED**, that the South Carolina Department of Transportation Commission request current approval from the Budget and Control Board to issue General Obligation "C" Fund Highway Bonds in the amount of \$500,000.00, said bond proceed to be used by the York County Transportation Committee for highway construction, and the York County Transportation Committee assuming responsibility for payment of the debt service associated with this bond issue out of their allocation of "C" funds.

SECTION 16: On motion of Commissioner Mack, seconded by Commissioner Jefferson, the Commission unanimously passed a motion adopting the following resolution recognizing Commissioner Loftus as "1995 South Carolina Hotelier of the Year":

### **RESOLUTION**

**WHEREAS**, Gary M. Loftus, of Myrtle Beach, has since 1994, rendered outstanding service to the motoring public and to the State of South Carolina, as a member of the South Carolina Transportation Commission from the First Congressional District;

**AND WHEREAS**, Mr. Loftus, who is General Manager of the Bar Harbor Motor Inn of Myrtle Beach, has been honored by the Hospitality Association of South Carolina as the 1995 Hotelier of the Year;

**AND WHEREAS**, the Association recognized Mr. Loftus as an "industry advocate extraordinaire;" as one who was "instrumental in assisting in the merger of the Hotel & Motel Association and the Restaurant Association, and whose vision is the reason that both industries have gained strength in our state legislature and regulatory agencies;

**AND WHEREAS**, the Association observed that Mr. Loftus has "a high level of energy, adventurousness and sociability; that what others see as backbreaking work, he sees as a challenge; that where others see risk, he sees opportunity; and that what others see as people problems, he sees as a people business;"

**AND WHEREAS**, these are the same traits that Mr. Loftus has demonstrated so effectively as a member of the Transportation Commission;

**NOW THEREFORE, BE IT RESOLVED**, that the South Carolina Department of Transportation Commission, in meeting duly assembled on this 16th day of November, 1995, does hereby congratulate Gary M. Loftus for the honor of being named 1995 South Carolina Hotelier of the Year, and recognizes this as another evidence of the outstanding services he renders to the people of South Carolina.

## SURPLUS RIGHT OF WAY PROPERTY - LAND

### 1. File 7.432 - SC Route 802 - Beaufort County

During acquisition of right of way for construction on SC Route 802 on Lady's Island in Beaufort County, under File 7.432, the Department acquired right of way from Jonas Robinson by Title to Real Estate dated September 29, 1976.

At the request of an adjoining owner, an investigation was made and it was determined that a portion of the above property was no longer needed and could be relinquished. Therefore, a quitclaim deed conveying approximately 0.05 of an acre parcel of land to Walter F. Lubkin, Jr., William P. Hendricks, and James E. Gay was executed on October 10, 1995, for consideration of \$1,100.00.

### 2. Barnwell Drive - Sumter County

A 40-foot drainage easement located between 1370 and 1384 Barnwell Drive in Sumter County was established by the developer when this property was subdivided.

At the request of an adjoining owner, an investigation was made and it was determined that the above right of way was not being utilized by the Department and would not likely be used in the future. Therefore, a gratis quitclaim deed conveying the 40-foot drainage easement to David Y. Shipman was executed on October 26, 1995.

### 3. File 10.362 - Roads S-269 & S- 270 - Charleston County

On March 29, 1952, under File 10.362, the Department added Roads S-269 and S-270 in Charleston County to the State Highway System. During improvements on Road S-269, the Department acquired right of way which included a triangular area from Georgie Brothers, A South Carolina Limited Partnership by Right of Way Easement dated March 29, 1989.

During negotiations by our Legal Section with an adjacent landowner, an agreement was reached that in exchange for right of way needed for the realignment of Roads S-269 and S-270, the Department would convey to the adjoining owner several residual parcels resulting from the relocation. Therefore, a gratis quitclaim deed conveying three tracts of land totaling approximately 0.164 of an acre to Ocean Boulevard Properties, A South Carolina Limited Partnership was executed on October 30, 1995.

4. File 5.375 - U. S. Route 321 - Bamberg County

During acquisition of right of way for construction of a roadside park along U. S. Route 321 in Bamberg County, under File 5.375, the Department acquired right of way by Titles to Real Estate from the Estate of G. F. Beard dated September 28, 1967, George Ervin Beard dated September 30, 1967, Earldine B. Hudson dated September 30, 1967, and Thelma B. Smith dated September 30, 1967.

At the request from the Mayor of the City of Denmark, an investigation was made and it was determined that the above property could be relinquished to the City of Denmark. The City of Denmark, by acquiring this property, will undertake the beautification and maintenance of this roadside park. Therefore, a gratis quitclaim deed conveying approximately 3.87 acres of land to the City of Denmark was executed on November 3, 1995.

This matter is reported to the Commission in accordance with the requirements of Code Section 57-5-340.
