LEGAL DESCRIPTION (Parcel No. 24-1/2 )

(As furnished by records of Richland County, S. C. )

All that certain piece, parcel or lot of land, situate, lying and being in the City of Columbia, County of Richland, State of South Carolina, and being the western one hundred feet of a lot heretofore conveyed to me by my father, Anderson Thompson, with the following boundaries and measurement, towit:

On the North by Entzminer, whereon it measures one hundred feet (100'), on the East by lands of grantor, whereon it measures fifty feet (50'), on the South by lands now or formerly of M. Ivory, whereon it measures a distance of one hundred feet (100') and on the West by lands of Dial and an alley or roadway, whereon it fronts for a distance of fifty feet (50').
