The print quality is fine for an 8x10, but, you have two options for printing.

I've attached two cropped versions:

State House\_Group shot DOA\_8x10\_pb: cropped exactly to print 8x10 (crops in sides from the left and right)

Group\_DOA\_8x10blackborder\_pb: This one retains the full width of the original image so the image area height is about 5.5" and there is a black border top and bottom.

The first option is the better as long as you don't mind cropping out some of the crowd on each side.
