

August 2, 1944.

The Budget Commission met in the Governor's office on August 2, 1944, at 12:00 o'clock Noon. All members of the Commission were present.

The Commission authorized the State Council of Defense to turn over to the State Sinking Fund Commission a Dodge automobile purchased with an appropriation for the State Council of Defense.

The Commission allotted to the State Hospital the sum of \$33,248.16 under the terms of a proviso carried under Section 25 of the General Appropriation Act for the fiscal year 1943-44, providing an additional appropriation for that institution.

The Commission authorized supplements of \$1,000.00, each, to the salaries of the President of The Citadel, Clemson College, University and Winthrop Colleges, the same to be paid from funds received from the Federal Government for military activities, or from Summer School Funds.

Dr. J. Rion McKissick, Mr. John A. Chase, and Mr. Frank F. Welbourne appeared before the Commission and discussed the salaries to be paid at the University for the fiscal year 1944-45, schedule of which was to be presented to the Budget Commission for approval. It was agreed that the salaries of the University could be submitted by semesters, with an estimate of the total annual salary of each employee; and that the Commission would approve the amounts to be paid by semesters. It was requested that such a schedule be submitted to the Budget Commission promptly, in view of the provision that salaries shall be approved by the Commission before becoming effective.

The Commission then adjourned.
