Service dispatch in order to report Mr. Perry Lee Johnson for removing an unloaded twelve (12) gauge shot gun from 155 REGAL RD. Lake Wylie South Carolina 29710. The residential address was then occupied by Mr. Floyd Henry Johnson and I Christopher Mark Phillips granted a legal redress of grievances against the County of York and the Bethel Kings Mountain Tax District on behalf of the Plaintiff and Civil Claimant seeking medical attention, Special needs Care, and personal security in regards a long-term family feud with immobile relatives and distant relatives seeking control of both land and financial accounts in which Floyd H. Johnson claims to have Security Interest with the United States Federal Government.

Mr. Floyd Henry Johnson Stated to I Christopher Mark Phillips Chief Federal Magistrate and United States Appeals Court Appointee that Mr. Jimmy Wilson pawned to him on loan the one shot twelve gauge shot gun for \$60.00 dollars. This statement was later confirmed by Miss _____ Wilson. Miss Wilson passed away during the period of my involuntary detainment and wrongful imprisonment. wherein Circumstantial evidence finds the Bethel Kings Mountain Court in direct violation of due process whereby Counsel was not granted while probate Court orders were not carried out as obligated. The York County public health and safety department must be and shall be called into question regarding the living conditions of Floyd Henry Johnson and the vindictive discriminating acts of negligence and defacto performance of 911 dispatch operators.

My public service to Mr. Floyd Henry Johnson resulted in acts of retaliation by local government workers found to be negligent in their duties and obligations to report the conditions in which Mr. Floyd Henry Johnson was abandoned with physical conditions such as dementia, prostate cancer, hearing deficiencies, and diminished sight. Mr. Floyd Henry Johnson complained of being a victim of continuous property thefts and white collar frauds, whereby local authorities often entered to the frauds of negligent health care workers, case workers, attorneys, law enforcement jurisdictional officers, jurisdictional Court officials, and family members. My attempts grant assistance resulted in the vindictive

prosecution of the various parties mentioned. Investigations are currently being conducted by both State and Federal Authorities. Yet, racial discrimination, pass-offs, and public corruption is a factor in which local government functions within the County of York must contend with.

The York County Sheriff's Department and the York County Court Jurisdiction of Clover/Bethel Kings Mountain did willfully, unlawfully Disparage the State and Federal Government in actions of Corruptions Concealed at present by un-warranted Motions of Investigation serving the interest of law-enforcement officers in violation of Constitutional rights, detention Center officers in abridgement of pre-trial detainee privilege wherein multiple acts prohibited by Staff-members are accepted trends un-challenged by Commanding officers while strategically Concealed by the York County Detention Center Classification Department.

The distortion of vital records and the fraudulent conveyance proven facts is the root of Corruption within the Bethel Kings Mountain tax district. Tax fraud, medical fraud, and property mismanagement are all signatures of the progressive disease of drug and alcohol addiction as well as the chemical dependency of prescription drugs.
