Governor Nikki Haley News:

The State: SC House approves \$24 billion state spending plan

The S.C. House gave a significant approval for next year's \$24 billion spending plan at 10:30 p.m. Tuesday after two long days of talks and votes. Representatives come back at 10 a.m. Wednesday for a final vote that should take less than two hours before sending the budget to the Senate.

Note: The spending proposal includes a 1.5 percent pay raise for state employees, 31 new State Law Enforcement Division agents and at least \$65 million for an education initiative backed by Gov. Nikki Haley.

Republicans say K-12 public schools are a big winner in the House budget plan approved late Tuesday, but Democrats criticized the plan as still not meeting the state's obligation to education. The House voted 115-2 in favor of a \$7 billion spending plan for state taxes and 105-4 on a separate bill that spends \$117 million from this year's rainy-day fund.

Note: Although the formulas remain, the House did adopt Gov. Nikki Haley's budget recommendations intended to simplify them and provide more to certain students.

Economic development and job creation have been key initiatives for Gov. Nikki Haley during her time in office. The governor touched on those subjects and much more Tuesday afternoon in Greenwood, as she was the guest speaker for the Rotary Club of Greenwood's meeting at American Legion Post 20 on Calhoun Avenue.

Note: "In 2011, when we started, unemployment was at 10.8 percent and got up to 11.1 percent," Haley said. "You made it very clear to me that jobs were a priority. So, that's what we did in South Carolina is jobs, jobs, jobs. We knew that in order for us to bring jobs to South Carolina we had to take care of the businesses we already had first, make sure that we had a strong business climate, make sure that we were really focused on how they were spending their dollar, making their dollar and how South Carolina was a part of that."

Aiken Standard: Congressmen: DOE plans to stop work at MOX facility

Members of the South Carolina congressional delegation said the Department of Energy is already planning to stop work at the MOX facility at the Savannah River Site. In a March 7 letter to S.C. Gov. Nikki Haley, U.S. Sen. Lindsey Graham, R-S.C.; U.S. Sen. Tim Scott, R-S.C.; and U.S. Rep. Joe Wilson, R-S.C., reported information about the mixed oxide fuel fabrication facility in Aiken County, known as MOX.

Note: Haley is speaking with S.C. Attorney General Alan Wilson about the issue, said Doug Mayer, Haley's spokesperson.

Note: "We are currently working with the attorney general's office and exploring any and all legal options in regard to this issue," Mayer said. "The governor has been actively engaged with this situation from the start and is committed to finding a solution – whether inside of a courtroom or not."

Anderson Independent: S.C. House passes \$24 billion state budget

The South Carolina House of Representatives passed a \$24 billion state budget Tuesday night. The budget, which includes \$6.9 billion in state appropriations, received preliminary approval 115-2 following two days of debate. After a final vote Wednesday, the spending plan will move to the state Senate for consideration.

Note: "Whether it's rising health care costs or not being able to keep your doctor, the past months have proven that Obamacare is wrong for our country and for our state and Governor Haley's decision to oppose it was the right one, and she stands by it," Haley spokesman Doug Mayer said. "The rest is just a distraction."

The state Department of Juvenile Justice would take charge of a public residential school for students with behavior problems, under a budget measure approved Tuesday by the South Carolina House. The House voted to give administrative oversight of John de la Howe School in McCormick to the Cabinet agency. The one-year takeover becomes part of the House budget plan for the fiscal year beginning July 1.

Note: "This type of intervention is necessary in order for these children to receive the services they need and to make it possible for the John de la Howe School to regain the respect it once so richly deserved," Haley wrote in the letter dated last Wednesday.

The state House of Representatives voted Tuesday to approve placing the John de la Howe School under the purview of the Department of Juvenile Justice. Gov.
