South Carolina Rep. Jeff Duncan is bringing back to Congress a comprehensive energy bill that would expand oil and gas drilling and encourage development of clean energy sources while rolling back some regulation on emissions that have contributed to a rise in energy prices in recent years. The bill probably is too broad and controversial to pass a bitterly divided Congress that has difficulty taking any decisive action. However, Duncan deserves a measure of credit for bringing forward genuine ideas to help improve the country's energy security in a time of transition between traditional energy sources and clean energy that is gaining favor but still is expensive to produce.

**Aiken Standard:** Clyburn bill requires testing drivers who cause fatal accidents

Drivers involved in fatal crashes in which people are killed or seriously injured would be scrutinized more closely under legislation proposed by a local lawmaker. S.C. Rep. Bill Clyburn, D-Aiken, is the sponsor of a bill that would require the operators of vehicles in such situations to be tested to determine if they were under the influence of alcohol or drugs. The testing would be conducted even if law enforcement officers did not suspect the drivers of being intoxicated. Clyburn pre-filed the legislation on Dec. 10, and it has been referred to the House Judiciary Committee.

A laptop stolen from an auditor's car contained the personal information of more than 3,400 members of a high-risk insurance pool set up in South Carolina for those unable to find coverage because of a medical condition, an attorney hired by the pool told The Associated Press on Monday. The password-protected laptop, stolen Oct. 16, contained names and Social Security numbers of 3,432 people who were part of the high-risk pool in 2011 and 2012, said Cynthia Hutto of Nelson Mullins Riley & Scarborough. The Legislature created the South Carolina Health Insurance Pool in 1989.

More than 3,400 customers who get health insurance through a South Carolina state-mandated program did not learn that a laptop containing their names and Social Security numbers was stolen until two months after the theft. The laptop was stolen Oct. 16 from the car of a private auditor hired to review S.C. Health Insurance Pool claims and payments, said Cynthia Hutto, a Charleston attorney hired to assist with the incident. The pool, run by insurers through the S.C. Department of Insurance, offers coverage to people who cannot get policies elsewhere.

The Medical University of South Carolina is taking on a drug manufacturing giant in a federal lawsuit that alleges the company is ripping off an MUSC scientist's intellectual property. MUSC's Foundation for Research Development and Charleston Medical Therapeutics filed the suit in federal court in mid-December against the Delaware-based AstraZeneca Pharmaceuticals for patent infringement. The plaintiffs argue in court papers that AstraZeneca should not be allowed to market and sell Crestor as a medication to treat patients with vascular inflammation without a history or risk of cardiovascular disease or stroke.

Boeing Co. told political leaders in the Seattle area on Monday that this week's vote by Machinists will determine the fate of some jobs on the new 777X airplane. Local politicians gathered at a press conference in Everett to discuss the importance of approving the revised contract offer. They said Boeing executive Ray Conner told them earlier in the day that an accepted contract will ensure that work on the airplane's wing stays in the Puget Sound area, but a vote to reject the deal will ensure the jobs go elsewhere.

South Carolina has the 11th-fastest-growing population of any state, growing faster than the nation as a whole and exceeding state forecasters' expectations. South Carolina had 4,774,839 residents on July 1, according to U.S. Census data released Monday. That's an increase of 51,422, or 1.1 percent, from July 1, 2012. That increase suggests that South Carolina is on track to surpass a projection by the S.C. Office of Research and Statistics that the state population will reach 4.8 million in 2015, said Mike MacFarlane, state demographer.

North Carolina and South Carolina keep growing at a strong clip. The U.S. Census Bureau announced Monday its national and state-by-state population estimates. It projected North Carolina's population at nearly 9.85 million people as of July 1. That's an increase of almost 100,000 people compared to July 2012. North Carolina is still ranked 10th highest among the states in population - ahead of New Jersey at No. 11 and just behind Michigan at No. 9.

Propelled by population growth in the greater Charleston area, South Carolina has been one of the faster-growing states in the nation since the 2010 Census, and new estimates suggest the pace is picking up. The Census Bureau released new estimates Monday that put South Carolina at No. 11 for population growth from July 2012 to July 2013. If it weren't for fracking, the Palmetto State would have made the top 10.



Hydraulic fracturing, or fracking, created a natural gas extraction boom that sent North Dakota to the top of the charts for both population and income gains during the past several years.

In an almost annual ritual, Congress is letting a package of 55 popular tax breaks expire at the end of the year, creating uncertainty — once again — for millions of individuals and businesses. Lawmakers let these tax breaks lapse almost every year, even though they save businesses and individuals billions of dollars. And almost every year, Congress eventually renews them, retroactively, so taxpayers can claim them by the time they file their tax returns. No harm, no foul, right? After all, taxpayers filing returns in the spring won't be hurt because the tax breaks were in effect for 2013.
