DMH staff believe this is no longer needed and we discussed internally recommending its deletion. Unfortunately we didn't have time to explore whether local officials might feel differently before the October 1 submission deadline.

We don't believe there would be opposition, but we will discuss with our regional management and advise.

As far as the money, there is approximately \$199,000 of the amount remaining. I believe some was used for a space study.
