People affected by the massive hacking of South Carolina's Revenue Department servers are being offered another year of free credit monitoring. But they'll have to sign up again, this time with a different company than the state used previously, as officials outlined Tuesday. Enrollment begins next week for protection through CSIdentity Corp. South Carolina is paying the Texas company up to \$8.5 million to provide credit monitoring to people affected by the September 2012 theft of unencrypted information from the Revenue Department's computer servers. Credit bureau Experian had been doing that work for nearly 1.5 million people under a \$12 million contract. Handled as an emergency situation, that contract was signed without competitive bidding.

Note: "No complaints so far. I don't anticipate any," Haley said. "People are thankful that we are continuing the protection."

**Policy** (Christian):

- The House GOP will mark-up a bill later today in the House Rules Committee to address the federal shutdown and lift the debt ceiling – it's unclear whether they have sufficient votes to pass it on the floor tonight, if it gets that far.

Potential Litigation – Last Friday, an organization called “Project Vote” (participants include the League of Women Voters and the NAACP) gave legal notice to several of our state agencies (HHS, DSS, DHEC, and DEW) alleging their failure to comply with National Voter Registration Act requirements. You may remember this Act being signed into law by President Clinton in 1992, which was referred to as “Motor Voter” for its requirement to have state DMVs (among other social service agencies) offer voter registration forms to citizens. We are following up with each agency to gauge their reactions to this notice and will keep you informed.

**Correspondence** (Hal):

We are getting correspondence concerning stand your ground laws since the ruling with the SC Supreme Court, correspondence about federal closings—general negative sentiment concerning the decision to not use state dollars to reopen parks/landings, the merger letter will get to her hopefully tomorrow—will be dated for Monday.
