Dear SUA and Fiscal Directors, please note the following:

1. Maintenance of Effort & Ombudsman Certifications

In accordance with ACL's Program Instruction ACL-PI-14-04, Certification of Maintenance of Effort for the Title III and Certification of Long-Term Care Ombudsman Program Expenditures for Fiscal Year 2013 must be signed by the authorized State agency official and submitted to the Regional Administrators, ACL, no later than **August 1, 2014**.

2. FY 2014 Transfer Requests

ACL Program Instruction (ACL-PI-14-03) provides the Procedures for Reporting the Transfer of Federal Fiscal Year 2014 Title III Mandatory Grant Funds. FY 2014 Transfer requests must be submitted to the ACL Regional Administrator no later than **August 15, 2014**. Please note that funds will not be available for drawdown from the Payment Management System (PMS) until the Administration for Community Living processes the transfer request and issues a revised Notice of Award.

3. Obligation of FY 2014 Grant Awards

FY 2014 Final Grant Awards were released on July 17, 2014. All FY 2014 Title III, Title VII, and NSIP grant awards are required to be obligated by **September 30, 2014**. FY 2014 funds that are not obligated by September 30, 2014, may not be expended and/or must be returned to the Federal Government. Please obligate all FY 2014 funds no later than September 30, 2014.
