Re: Medicaid Rate Reduction effective July 8, 2011

Dear Director Keck:

I have been contacted by Jeff Reece, the administrator of Marlboro Park Hospital which is the local hospital in my district in Marlboro County. This already very small facility was forced to reduce their staff by three positions as a result of the 3% rate reduction in April of this year. With this additional 4% reduction effective on Friday, additional positions will likely be lost.

Marlboro County has consistently been in the top two positions for unemployment in the state for the last few years. We cannot afford to lose any additional jobs or influx of money into our local economy. In addition to our high unemployment rate, a large portion of our population has Medicaid coverage (approximately 35%). This facility has little private pay/private insured clientele to offset the reduction of payments from Medicaid.

The reduction would further affect the access to health care and may cause the reduction in services able to be offered at our hospital. The elderly and poor in our community do not have public transportation readily available to them to commute to a larger hospital where more services are available. I understand that Chesterfield General Hospital was exempted from the rate reduction. It lies in our neighboring county -- Chesterfield County. Marlboro Park actually lies in a much poorer and less populated county. Marlboro Park, in fact, has only 50-60% of the admissions that Chesterfield General has. As a result, Marlboro Park has far less revenue with which to dilute this reduction.

I request that you reconsider your decision to apply this rate reduction to Marlboro Park. Marlboro County meets the rural designation for many other purposes. Our only hospital and access to health care for many in our county will be jeopardized by

the application of your reduction to Marlboro Park. I ask that we be given the same treatment as those similarly situated (i.e. Chesterfield General Hospital).

Please advise me as soon as possible as to your determination in this very important matter. With kind regards, I am,

Dear Representative Munneryn:

Thank you for your letter regarding the impact of the Medicaid reimbursement reductions on Marlboro Park Hospital in Bennettsville, South Carolina.

The South Carolina Department of Health and Human Services has reviewed the exception criteria that was used to determine the hospitals exempt from the July 11, 2011, rate reductions. Based upon additional data from the University of South Carolina Institute of Families in Society, we will also exclude three more hospitals from receiving the recently executed 4% reductions. The updated description of exempt hospitals as well as the added hospitals are as follows:

- Hospital services provided by qualifying burn intensive care unit hospitals,
- Critical access hospitals and isolated rural,
- Small rural and certain large rural hospitals as defined by Rural/Urban Commuting Area classes,
- Large rural hospitals must be located in a Health Professional Shortage Area for primary care for local population,
- Chester Regional Medical Center, Colleton Medical Center and Marlboro Park Hospital.
