8 Days of salary based on the average program manager salary. **Average Salary - \$71271/1950 hours+\$36.55/hour \* 60 hours (7.50 hours per day) = \$2,193**

**Total Estimate \$2,291.01**

The House 3M Committee has requested a fiscal impact statement on H. 4935, which can be found here: [http://www.scstatehouse.gov/sess122\\_2017-2018/bills/4935.htm](http://www.scstatehouse.gov/sess122_2017-2018/bills/4935.htm).

The bill creates the SC Palliative Care and Quality of Life Study Committee. There will be one representative of the Division on Aging on this committee.

This is the language I plan to use with your approval:

"Each member will receive per diem of \$35, subsistence of \$202.03, and mileage of \$0.54 per mile for each meeting on non-session days. These expenses will be managed within the budgets of the appointees' respective legislative bodies. Therefore, the bill does not have an expenditure impact on the General Fund, Other Funds, or Federal Funds for the Office of the Lieutenant Governor."

Please review the bill and let me know if you agree or see any other expenditure impact that this bill may have, by COB on Thursday, February 22<sup>nd</sup>.
