Mr. Watson presented first reading of Ordinance #171 - 1985-86 proposed budget. Mr. Watson explained the following proposed rates:

General Fund - 22.7 Mills
Debt Service - 8 Mills
County Library - 3.5 Mills
Tri-County Technical College - 2 Mills
6.8 MILLAGE INCREASE OVER 1984-85 BUDGET

Included in the 6.8 millage increase:

3.0 - Proposed Sewer Project
1.0 Flight Service Center
.4 Tri-County Technical College
.7 - County Library
1.7 - General Fund
TOTAL 6.8 Mills

The administrator's total proposed budget for 1985-86: \$12,452,229.00. Mr. Cox moved that first reading of Ordinance #171 (1985-86 budget) be approved as presented. Mr. Hooper seconded. Vote was unanimous.
