

Summary of Violations Per Riverwalk Academy's Published Code of Conduct

Riverwalk Academy Code of Conduct Jan 11, 2016

- ❑ **Security Breach** with parents being allowed in a classroom setting to intimidate other children on their child's behalf **(p.3 Learner Rights: To pursue a successful education in a safe environment... Parent Partner Rights To expect [a] safe learning environment for their child(ren.)**
- ❑ **Ineffective Conflict Resolution** by classroom teacher and administrators **(p.3 Learner Rights: To receive fair and equitable treatment without discrimination in every aspect of the educational system To be given the opportunity to be heard, as well as, have witnesses and/or an advocate speak on one's behalf.)**
- ❑ **Ineffective Communication and Engagement from Principal Charlie French**, where she simply refuses to respond to emails and voicemail to address concerns and resolve issues **(p.3 Parent Partner Rights: To request and be granted conferences with school personnel**

☐ Ineffective Communication and Engagement from Principal Charlie French,

- Repeated requests for in person conference via email were ignored
- Voicemails weren't returned
- Meanwhile another parent, who avoided the bureaucratic protocol, just walked in off the street (there are no metal detectors) and went into the classroom, had her child point out **my child, Noah Baldwin**, and put him at risk on school property with threatening behavior (**p.4 Parent Partner Responsibilities: To respect the rights, dignity, and confidentiality of learners, parent partners, guardians and staff .)**




Good afternoon,

Hello Mrs. French,

I understand that you had a phone meeting with Mrs. Baldwin, but we still need an **in person meeting** to discuss whatever has been documented in Noah's folder - with full disclosure and copies.

I'm just going to be honest with you, trust is a major issue at this point and we don't feel comfortable with just phone interaction. We also have no confidence that anything has been documented on the child who came up to Noah while he was working quietly, snatched his drawing and tore it in half - which was what precipitated Noah defending himself in the first place. Supposedly, the teacher witnessed this exchange and did nothing when the paper was snatched and destroyed. How is that possible? I understand your policy on privacy, but you need to understand our position on accepting you at just your word given the situation and our experiences thus far.

We have a list of grievances that have not been addressed and we will need a satisfactory resolution on those, or we will be forced to escalate to the state level and the media.

This is just a sample:

- **Noah has been targeted by adults (Mrs. Stookey)**
- **Has been bullied by other students for his hair, his drawings and career aspirations,**
- **Has "lost" two expensive hoodies in the Iwin program in the last month**
- **Had other students refuse to acknowledge him in the roles of leader/timer/scribe for projects, etc.**
- **There is a bigger issue here and we want it addressed and resolved. If you don't feel confident handling it at the school, we will get the help we need from a higher level.**

Please advise what time you are available to have an in person conference with us.

Hi Ms. Roddy,

I tried calling you back twice today. In regards to Noah's lunch, he actually forgot it on the kitchen table today.

Secondly when picking him up you advised Noah to explain to me what happened in class today. **To begin with my child advised that he was sitting in his seat working on an assignment/paper and another child walked over to his personal space asking to see it. Noah responded NO to that child. Next the child took my child's paper and ripped it in half.** That was very inappropriate. I'm also concerned about your whereabouts during the incident?? To my understanding you didn't witness any of this? **This other child needs to be reprimanded as well.**




